For divorces from 1994 to present, a search can be done using either the wife's maiden name or the husband's name. A fee of \$15.00 is charged for the search of the year and the name entered above. The fee is charged even if no record is found. If you want to search more than one year of records, please enclose \$15.00 for each additional year. The Office of Vital Records maintains divorce records for the past fifty (50) years only. Earlier records may be obtained from the State of Tennessee Library and Archives or from the clerk of the court where the divorce was granted.
