The comments received at this hearing will be presented to the Tennessee Air Pollution Control Board for their consideration in regards to the proposed regulatory amendments. Tennessee proposes to amend Chapter 1200-03-10 Required Sampling, Recording, and Reporting by adding a new Rule 1200-03-10-.05 (Emissions Inventory Requirements). This rule would require affected sources to submit emission inventory information consistent with the provisions of 40 CFR Part 51, Subpart A. Interested parties may submit comments on any provision of the proposed rule.

Tennessee is specifically soliciting public comments on the deadline established in paragraph 1200-03-10-.05(1). Paragraph (1) requires affected sources to submit emissions inventories no later than June 1 of each calendar year. Tennessee requests comment on whether the rule should allow the Technical Secretary to extend the June 1 deadline, and the specific circumstances under which a deadline should be granted.

Revisions considered at this hearing may be adopted by the Tennessee Air Pollution Control Board under T.C.A. 68-201-105, the Board general authority to promulgate rules. All persons interested in the air quality of the State of Tennessee are urged to attend and will be afforded the opportunity to present testimony to the hearing officer regarding the proposed revisions to the State Implementation Plan. Any person desiring to present lengthy comments should be prepared at the hearing to offer a written statement to be incorporated into the record. Written statements not presented at the hearings will only be considered part of the records if received by 4:30 PM on November 2, 2016, at the office of the Technical Secretary, Tennessee Air Pollution Control Board, William R. Snodgrass Tennessee Tower, 312 Rosa L. Parks Avenue 15th Floor, Nashville, TN 37243.

The table of contents to Chapter 1200-03-10 Required Sampling, Recording, and Reporting is amended by adding a new rule to the table to read as follows:

Chapter 1200-03-10 Required Sampling, Recording, and Reporting is amended by adding a new rule to read as follows:

1200-03-10-.05 Emissions Inventory Requirements

(1) Stationary sources that exceed the emission thresholds specified in 40 CFR 51 Subpart A shall submit emissions inventories no later than June 1 of each calendar year. Emissions inventories shall be submitted in accordance with the requirements of 40 CFR 51 Subpart A and using the format provided by the Technical Secretary.

(a) Sources subject to paragraph (11) of Rule 1200-03-09-.02 shall certify the truth, accuracy, and completeness of emissions inventories pursuant to part (11)(d)4 of Rule 1200-03-09-.02.

(b) For sources that are not subject to paragraph (11) of Rule 1200-03-09-.02, the responsible person for the facility shall certify emissions inventories with the following statement: "Based upon information and belief formed after a reasonable inquiry, I, as the responsible person of the above mentioned facility, certify that the information contained in this application and any attached application(s) is accurate and true to the best of my knowledge. As specified in T.C.A. § 39-16-702(a)(4), this declaration is made under penalty of perjury."
