FORMER PRESIDENT OF THE BOARD OF MEDICAL EXAMINERS STEPS DOWN

MITCHELL MUTTER, MD NAMED MEDICAL DIRECTOR FOR SPECIAL PROJECTS

Mitchell Mutter, MD, FACC, a former chief of staff for UT-Erlanger Hospital in Chattanooga and currently a cardiologist at that facility, joined the Tennessee Department of Health in August as medical director for special projects. Mutter's duties will include liaison services with the Board of Medical Examiners, the Board of Nursing and the Board of Pharmacy.

"Mitchell Mutter is one of our state's most respected physicians and brings the passion and commitment needed to drive improvements affecting the health and well-being of all Tennesseans," said TDH Commissioner John Dreyzehner, MD, MPH. "While he will work with several boards and outside associations, areas of special emphasis for him will be the recently enacted Tennessee Prescription Safety Act and the TDH Controlled Substance Monitoring Database Oversight Committee."

"The state of Tennessee will benefit tremendously from Dr. Mutter's medical expertise and leadership skills," said Charlesetta Woodard-Thompson, president and CEO of the Erlanger Health System. "Dr. Mutter has always been one of Erlanger's strongest advocates, as well as one of Chattanooga's most respected physicians, and we know he will make a positive impact on the health of all Tennesseans with his new position."

Mutter received his medical degree from UT-Memphis. The former UT football player did his internship and residency training at Walter Reed Army Medical Center, and later served as chief of cardiology at Eisenhower Medical Center at Fort Gordon in Augusta, Ga. He was named the Tennessee Medical Association's Outstanding Physician in 2007, and also received the Medical Staff Meritorious Service Award from the Tennessee Hospital Association in 2007. Recently he received the 2012 Distinguished Physicians Award from Erlanger Baroness Foundation.

Mutter is a former president of the Hamilton County Medical Society, the Tennessee Heart Association and the Hamilton County Medical Foundation, and current president of the Tennessee Board of Medical Examiners. He also founded the Children's Nutrition Program of Haiti, an effort he established after his first trip to that country in 1988 to provide medical services and develop a grassroots nutrition program.

MISSION OF THE BOARD

The Tennessee Board of Medical Examiners is committed to carrying out its mission to safeguard the health, safety, and welfare of Tennesseans by requiring those who practice medicine and surgery within this state be qualified. The Board awards licenses to qualified candidates who have graduated from approved medical schools and who have completed appropriate postgraduate work. The Board interprets the laws, rules, and regulations to determine the appropriate standards of practice in an effort to ensure the highest degree of professional conduct. The Board is responsible for the investigation of alleged violations of the Practice Act and rules and is responsible for the discipline of licensees who are found guilty of such violations.

Through the licensing process, the Board ensures that the professionals we regulate meet the standards of education, training and professional conduct necessary to serve Tennessee patients effectively and safely. In 2011, the Board issued the following licenses:

ASSISTANCE TO IMPAIRED PRACTITIONERS

The Board is authorized by TENN. CODE ANN. SECT. 63-1-136 to enter into agreements or provide grants to statewide non-profit organizations for the purpose of assisting impaired professionals. The Board provides a grant of \$250,000 to the Tennessee Medical Associations' Physicians Health Program.

TENNESSEE BOARD OF MEDICAL EXAMINERS' POSITION STATEMENT HORMONE REPLACEMENT THERAPY

On January 24, 2012, the Board of Medical Examiners adopted the following policy relative to hormone replacement therapy. The purpose of this policy is to provide guidance to licensed prescribing practitioners who determine that the use of hormone replacement therapy is medically appropriate for a patient.

If a licensed prescribing practitioner during the course of treatment of, and in consultation with, a patient determines that hormone replacement therapy is an appropriate course of action, the Board of Medical Examiners, after consultation with the Board of Osteopathic Examinations, Board of Nursing and the Committee on Physician Assistants believes that the initiation of such therapy must be based on accepted scientific knowledge and sound clinical grounds. Before initiating hormone replacement therapy, a licensed prescribing practitioner **must**:

(a) Take special care to properly educate his/her patient. Patient education is the process of influencing patient behavior and producing the changes in knowledge, attitudes and skills necessary to maintain or improve health. Patient education is critically important because evidence suggests that counseling and patient education provides substantial benefits. Providing patients with complete and current information helps create an atmosphere of trust, enhances the healthcare provider-patient relationship and empowers patients to participate in their own health care. Effective patient education also ensures that patients have a sufficient level of knowledge and understanding, which allows them to make informed decisions regarding their care.

(b) Conduct an initial evaluation of the patient which shall be recorded by the licensed prescribing practitioner (practicing within his/her scope of practice) **prior** to the initiation of hormone replacement therapy. Such evaluation should include an appropriate physical and complete history; appropriate tests; diagnosis; proper indication for the use of the therapy and appropriate medical referrals as indicated by the physical, history, testing and diagnosis; all in accordance with general medical standards of care. Relative contraindications to the use of hormone replacement therapy should be addressed prior to prescribing or dispensing and the patient must be counseled about the risks and benefits associated with the planned therapy and the consultation must be recorded in the patient's chart. Further, it is expected that the licensed prescribing practitioners will monitor the patient's response to therapy based on follow-up visits to assess the effectiveness of the therapy, manage any complications that flow there from, and document the rationale for continuing or modifying the therapy.

(c) Document in the patient's medical chart an informed consent wherein the patient is fully informed about the risks and benefits of the planned therapy sufficient to allow the patient to participate in making choices about his/her

health care. The Board adopts *Opinion 8.08* of the "Code of Medical Ethics" published by the A.M.A. Council on Ethical and Judicial Affairs as it may, from time to time be amended, relative to informed consent.

(d) Insure the adequate medical supervision of allied healthcare providers who are practicing within their scope of practice and pursuant to protocols jointly developed and in accordance with existing statute and rules. Supervision as applied to certified nurse practitioner/prescription writers and physician assistants is governed by Medical Board rules Chapter 0880-6 and 0880-2-.18 respectively.

(e) Advertise hormone replacement therapy in a manner consistent with Tenn. Code Ann. Sect. 63-6-214 (b) (3), (8), and (9) Rule 0880-02-.13 of the Rules and Regulations that Govern the Practice of Medicine.

If a licensed prescribing practitioner fails to abide by the guidance contained herein, he or she may be subject to disciplinary action by the appropriate health-related board with jurisdiction over his/her professional license.

REMINDER REGARDING CONTINUING EDUCATION

The Board's administrative office randomly audits renewal applications to determine compliance with continuing medical education requirements. Each licensee, as a condition of renewal, must obtain 40 hours of category 1 CME during the two calendar years immediately preceding renewal. **Remember:** At least one hour must address prescribing practices.

STATUTORY CHANGES OF INTEREST TO TENNESSEE PHYSICIANS



The 2012 Legislative Session has ended, and the Administrative Staff has monitored several bills that are of interest to physicians in the state of Tennessee. These public chapters are available on line at:

Public Chapter 961

Regulates the practice of interventional pain management, defined as the performance of invasive procedures involving any portion of the spine, spinal cord, sympathetic nerves of the spine or block of major peripheral nerves of the spine, outside of facilities licensed under Title 68. Provides that advanced practice nurses and physician assistants may only perform such procedures under the direct supervision of an appropriately qualified medical or osteopathic physician (as defined under the statute). These restrictions do not apply to the performance of major joint injections other than sacroiliac injections or to soft tissue injections or epidurals for surgical anesthesia or labor. Direct supervision requires the supervising physician to be physically present in the same building at the time of the procedure. Medical and osteopathic physicians may only practice or supervise the practice of interventional pain management if the physician is board certified by certain enumerated boards, is in a practice relationship with a physician who is so qualified, is board certified by a board other than those enumerated and has completed an approved post-graduate training program, is a clinical instruction in pain medicine at a Tennessee accredited medical training program, or is in the active practice of pain management in a clinic accredited by the Accreditation of Rehabilitation Facilities in outpatient interdisciplinary pain rehabilitation

Public Chapter 723

Continues the Committee for Clinical Perfusionists until June 30, 2016. Revises certain provisions regarding appointments to the committee.

Public Chapter 869

Amends definition of pain management clinic. Amends and clarifies exemptions for schools and hospitals and their associated clinics and training programs. Extends deadline to register as a pain management clinic to October 1, 2012 for those operating prior to January 1, 2012. Provides a right to appeal under the Uniform Administrative Procedures Act for those denied a certificate or denied renewal of a certificate. Provides that certificate holders may inactivate the certificate upon notice to the department.

Public Chapter 818

Provides medical and osteopathic physicians immunity from civil liability when reporting to law enforcement suspected unauthorized use of the physician's DEA registration when such report is made in good faith.

Public Chapter 945

Changes the number of months a dentist has to have seen a patient before the dental hygienist can work under general supervision from seven (7) to eleven (11) months and authorizes dental hygienists to practice under direct and/or general supervision in the office of a licensed dentist and under general supervision of a dentist through a written protocol in authorized public health programs, nursing homes, skilled care facilities and nonprofit clinics.

No dentist may enter into a written protocol with more than three (3) dental hygienists at any one time or may any hygienist be engaged in a written protocol with more than three (3) dentists at any one time. Each written protocol will be valid for a period of two (2) years and must be renewed through resubmission to the board. The dentist must notify the board within ten (10) working days if the dentist ceases to be the employer/supervisor of a dental hygienist where a written protocol is in force and on file with the board.

For dental hygienists to practice under general supervision under a written protocol he/she must have actively practiced for at least five (5) years and have practiced two thousand (2,000) hours in the preceding five (5) years **or** taught dental hygiene courses for two (2) of the preceding three (3) years in an accredited dental hygiene program and completed six (6) hours of public health continuing education within the past two (2) years. After meeting this requirement, the dental hygienist may work on a part-time basis.

Each written protocol shall be submitted to the board and shall include at a minimum the name, address, telephone number and license number of the employer (supervising) dentist and the dental hygienist, the name address, telephone number and other pertinent identification from all locations where the dental hygiene services are to be performed, and a statement signed by the dentist that the dentist and the dental hygienist meets all minimum standards for general supervision as well as those required for practice under a written protocol.

Public Chapter 650

Continues the Board of Medical Examiners until June 30, 2016. Revises certain provisions regarding appointments to the board.

Public Chapter 630

Continues the Board of Respiratory Care until June 30, 2016. Revises certain provisions regarding appointments to the board.

Public Chapter 629

Revises certain provisions regarding appointments to the Board of Examiners in Psychology.

Public Chapter 697

Revises certain provisions regarding appointments to and vacancies on the Board of Communications Disorders and Sciences.

Public Chapter 695

Revises certain provisions regarding appointments to the Board of Veterinary Medical Examiners.

Public Chapter 628

Revises certain provisions regarding appointments to the Board of Dentistry.

Public Chapter 836

Provides that all hormone replacement therapy, as defined in the statute, must be performed by medical or osteopathic physicians or by certified nurse practitioners or physician assistants acting under a delegation of such a physician and under written protocols. If delegated to a certified nurse practitioner or physician assistant, the patient must be provided certain information. Requires a physician supervising hormone replacement therapy in hormone replacement therapy clinics, as defined in the statute, to ensure that appropriate physical examinations and medical histories are taken and documented, that appropriate written informed consent is obtained, and that a written order for hormone replacement therapy is contained in the record and documented by a diagnosis justifying the order. The supervising physician must review the patient chart and so certify in the chart within seven days of the order. Hormone replacement therapy clinic is defined as a medical office in which a majority of the clinic's patients receive hormone replacement therapy, but does not include a medical office in which the providers are primarily engaged in obstetrics and gynecology, urology or primary care.
