1. Make application on Form (RV-F1321901) and support application with a copy of Lien Instrument, Owner's Tennessee Certificate of Title* (if no existing lien) and payment. For a listing of county clerk contact information, please visit <http://www.tn.gov/revenue/article/county-clerks-locations>

* an application for duplicate title is not acceptable

2. Fee for Noting of Lien is \$11.00 per new lien plus \$5.50 state title fee (please contact county for additional county fees)

Note: The requirements for noting a second lien are the same as above except the Certificate of Title is not necessary. Name and address of Lienholder must be shown on Form (RV-F1321901) in the space indicated by "2nd Lienholder."

A Conditional Sales Contract is not acceptable as a Lien Instrument unless previously recorded and merely being assigned.
