Dear Mr. Gordon:

This letter is to inform you that the Centers for Medicare & Medicaid Services (CMS) is granting a temporary extension of Tennessee's section 1115 demonstration, TennCare II (Project Number 11-W-00151/4). The temporary extension is effective through September 30, 2016.

The temporary extension period will give CMS and Tennessee the opportunity to finalize terms and conditions of a longer extension of the demonstration. We continue to make good progress toward finalizing the terms for an extension of uncompensated care funding under the demonstration that is consistent with the principles CMS articulated in its November 2015 letter: coverage is the best way to assure beneficiary access to health care for low income individuals and uncompensated care pool funding should not pay for costs that would otherwise be covered in a Medicaid expansion; Medicaid payments should support the provision of services to Medicaid and low income uninsured individuals; and provider payment rates must be sufficient to promote provider participation and access, and should support plans in managing and coordinating care.

In the interim, this temporary extension includes continued federal funding available to Tennessee to make uncompensated care payments to providers.

During this extension period, CMS and Tennessee will work towards agreement on finalizing the terms of uncompensated care payments under the demonstration in the next demonstration period. Payments made during the temporary extension toward provider costs that were incurred prior to July 1, 2016 will not be counted toward the uncompensated care pool spending limit that we agree upon for the next demonstration period, and the limit during the temporary extension is set consistent with the prior year's spending limit. Payments made toward provider costs that are incurred on or after July 1, 2016 will count toward the spending limit in the following demonstration year (which may be subject to negotiation in a longer extension of the demonstration).

All other STCs, waiver and expenditure authorities remain in effect and the per-member-per-month (PMPM) costs approved for the most recent demonstration period will be used to determine budget neutrality for this temporary extension period.
