- RENEWAL FEE IS \$50.00 FOR TWO YEARS.
- MAKE CHECK PAYABLE TO CONTRACTOR'S BOARD – LLE and INCLUDE LICENSE NUMBER ON CHECK
- MAIL FEE WITH THIS FORM, TO THE ADDRESS ABOVE
- LATE FEE IS \$10.00 per month if received (not postmarked) after expiration date; MAXIMUM UP TO THREE (3) MONTHS AFTER EXPIRATION DATE
- LICENSE CANNOT BE RENEWED IF EXPIRED IN EXCESS OF THREE (3) MONTHS (allow 5 to 7 business days for mail delivery)
 (Example, if your licensed expired on 9/30/2009, cannot renew after 01/01/2010 and must complete the LLE application for reinstatement; may be required to take the LLE test or request waiver)
