AMERICAN NATIONAL LAWYERS INSURANCE RECIPROCAL RECEIVER'S  
MOTION FOR THE COURT TO ACCEPT AND APPROVE NUMEROUS FINAL  
DETERMINATIONS AS TO ENUMERATED CLAIMS AND TO APPROVE  
PAYMENTS OF APPROVED CLAIM AMOUNTS FOR  
APPROVED CLASS 5, CLASS 6 AND CLASS 7 CLAIMS

---

I. INTRODUCTION

Julie Mix McPeak, as Commissioner of the Tennessee Department of Commerce and Insurance, in her capacity as Receiver/Liquidator ("Receiver") of American National Lawyers Insurance Reciprocal (RRG) in Liquidation ("ANLIR"), and through her appointed Special Deputy Receiver, moves the Court, under T.C.A. §56-9-331, to accept and approve, as final, the Class 5 and Class 8 determinations set forth in **Exhibit A**. This Motion does not request approval of a distribution, pro rata or otherwise, as to the approved Class 8 claim amounts set forth in **Exhibit A**, but rather only seeks acceptance and approval of the three listed Class 8 claims. As to payment distributions, this Motion seeks approval of 100% payment of the

approved Class 5 claims listed in **Exhibit B**<sup>1</sup>, the approved Class 6 claims listed in **Exhibit C** and the approved Class 7 claims listed in **Exhibit D**.

## II. DISCUSSION

### A. Requested Acceptance and Approval of Class 5 and Class 8 Claim Determinations.

Until recently, there remained four Class 5 claims which had not been finalized – POCs 2364, 2389, 2391 and 2392. The Claimants as to these claims are Reciprocal of America (“ROA”) or The Reciprocal Group (“TRG”), which are entities related to ANLIR currently in receivership/liquidation proceedings in Virginia. The ANLIR Receiver and these claimants have reached agreement as to the adjudication and finalization of these POCs. As part of that agreement, on June 16, 2016, the ANLIR Special Deputy Receiver issued Final Agreed Notices of Determination setting forth the Approved Claim Amounts as to each of the above-referenced Class 5 claims. The Claimants (ROA and TRG) have agreed not to object to the Final Agreed Notices of Determinations and have waived the thirty (30) day objection period under T.C.A. §56-9-327. **Exhibit A** sets forth the agreed upon final determinations of those Class 5 claims. Pursuant to T.C.A. §56-9-331, the ANLIR Special Deputy Receiver recommends, and moves, that the Court (a) accept this report as to the enumerated Class 5 final claim determinations set forth in **Exhibit A** and (b) approve the final claim amounts listed for these claims.

The ANLIR Special Deputy Receiver and TRG have also reached agreement as to the final determination of three Class 8 claims to which TRG is the Claimant – POCs 2390(A), 2390(B) and 2390(C). It was agreed that the approved claim amounts of each of these Class 8 claims be set at \$0.00. As part of that agreement, on June 16, 2016, the ANLIR Special Deputy

Receiver issued Final Agreed Notices of Determination setting forth those \$0.00 amounts as the approved claim amounts for each of these Class 8 claims. TRG has agreed not to object to the Final Agreed Notices of Determination and has waived the thirty (30) day objection period under T.C.A. §56-9-327. In addition to setting forth the Class 5 claims referenced above, **Exhibit A** also sets forth the agreed upon \$0.00 final determination of those Class 8 claims. Pursuant to T.C.A. §56-9-331, the ANLIR Special Deputy Receiver recommends, and moves, that the Court (a) accept this report as to the enumerated Class 8 final claim determinations set forth in **Exhibit A** and (b) approve the final claim amounts of \$0.00 for each of these claims.

**B. Requested 100% Distribution as to Approved Claims Amounts for the Approved ANLIR Class 5, Class 6 and Class 7**

With the presentation, acceptance and approval of the ROA and TRG Class 5 final claim determinations above, all ANLIR Class 5 claims have been adjudicated, finalized, and have been accepted and approved by the Court (*see* Court Order entered on July 2, 2015 for acceptance and approval of all non-ROA/TRG Class 5 claims). **Exhibit B** hereto sets forth all of the finalized and approved ANLIR Class 5 claims and the final approved claim amounts for each claim (albeit that some are \$0.00). The total approved claim amount for all of the Class 5 ANLIR approved Class 5 claims, set forth in **Exhibit B**, is \$2,262,487.66.

By previous Order of Court entered on April 7, 2016, all of the ANLIR Class 6 claims have been adjudicated and finalized and have been accepted and approved by the Court. **Exhibit C** hereto sets forth all of the approved ANLIR Class 6 claims and the final approved claim amounts for each claim. The total approved claim amounts for all of the ANLIR Class 6 approved claims, set forth in **Exhibit C**, is \$32,219.79.

By previous Order of Court entered on December 28, 2015, all of the ANLIR Class 7 claims have been adjudicated and finalized and have been accepted and approved by the Court.

**Exhibit D** hereto sets forth all of the approved ANLIR Class 7 claims and the final approved claim amounts for each claim (albeit that some are \$0.00). The total approved claim amounts for all of the ANLIR Class 7 approved claims, set forth in **Exhibit D**, is \$177,99574.

Through this motion, the ANLIR Special Deputy Receiver requests approval of the 100% payment of the Class 5, Class 6 and Class 7 approved claim amounts, which, in the aggregate, totals **\$2,472,703.88**.

**C. Adequate Assets Are Available For Requested Payments Along with Reserving for Administrative Expense Claims and Pending Class 2 Claim.**

Adequate assets exist from funds jointly recovered by ANLIR and its sister RRG companies (Doctors Insurance Reciprocal, RRG (in Liquidation) (“DIR”) and The Reciprocal Alliance, RRG (in Liquidation) (“TRA”)) so as to pay the above-referenced \$2,472,703.88 on the ANLIR Class 5 – Class 7 approved claim amounts while also reserving funds for anticipated administrative expenses of the ANLIR Liquidation Estate and the payment of the full claimed amount of the remaining group of ANLIR Class 2 claims that are still pending (the Elliott Lawson and Minor claims – “Elliott Claim”). Other than the anticipated administrative expense claims and the Class 2 Elliott Claim, which are being reserved for, there are no other claims pending in the ANLIR Liquidation Estate that are superior in priority to the Class 5 – Class 7 claims, payment of which is sought through this Motion. The only other claim in the ANLIR Liquidation proceedings that has not been adjudicated to finality (except the referenced Class 2 Elliott Claim) is a claim by Lawyers Management Corporation (“LMC”) (POC #246). That claim received its Class 8 classification through a Notice of Determination previously issued by the ANLIR Special Deputy Receiver, and no objection to that claim classification was made

within the time frame allowed. Accordingly, that Class 8 claim classification is final<sup>2</sup>. Because adequate funds are being reserved for administrative expenses and for the maximum amount claimed in the Class 2 Elliott Claim, and because the remaining claim is a Class 8 claim, the requested payment of 100% of the approved ANLIR Class 5 – Class 7 claim amounts is consistent with T.C.A. §56-9-333(a).

### III. NOTICE

Notice will be provided to ROA and TRG through mailing a copy of this Motion and Exhibits to counsel for their Virginia Deputy Receiver. Notice will be provided to the Elliott claimants (the sole remaining group of Class 2 ANLIR claimants with an unresolved claim) through mailing a copy of this Motion and Exhibits to their counsel. Notice will be provided to LMC through mailing a copy of this Motion and Exhibits as set forth in the Certificate of Service to this Motion. Because the other ANLIR Class 2 claims and the Class 3 and 4 claims (if any) have already been finalized and paid, no notice will be provided to them of this Motion. Every Class 5 - Class 7 claimant listed on **Exhibits B, C and D** will be sent a postcard notice to each claimant's address as shown in the ANLIR Liquidation Estate's records. That postcard notice will inform the claimant of the filing of this Motion, the hearing date, time and place, the deadline for response to the Motion, a short description of the relief sought in the Motion and a reference to the Tennessee Department of Commerce and Insurance website where a complete copy of this Motion and Exhibits will be posted. Attached as **Exhibit E** is a template of that "postcard" notice.


**IV. REQUEST THAT ORDER GRANTING REQUESTED RELIEF BE MADE FINAL PURSUANT TO RULE 54.02 TENN. R. CIV. P.**

This Motion seeks relief that needs to be relied upon in advancing the progression of the ANLIR Liquidation Proceedings toward ultimate closure. But the relief afforded through granting this Motion does not address all matters at issue in the ANLIR Liquidation Proceedings. In order to provide certainty with regard to the relief granted, the ANLIR Receiver requests that the Court expressly find that there exists no just reason for delay and that the Order granting this Motion be entered as final regarding the matters addressed in that Order. Rule 54.02 Tenn. R. Civ. P.

**V. CONCLUSION**

For the reasons set forth herein, the ANLIR Receiver requests this Court, pursuant to T.C.A. §56-9-331, (1) accept **Exhibit A** attached hereto as a report and listing of certain Class 5 and Class 8 claims set forth therein, (2) approve the claim amounts set forth in **Exhibit A** for each such Class 5 and Class 8 claim set forth therein, (3) approve 100% payments of the approved claim amounts set forth in **Exhibits B – D**, and (4) incorporate the listings set forth in **Exhibits A – D** in a final order granting the relief requested herein.



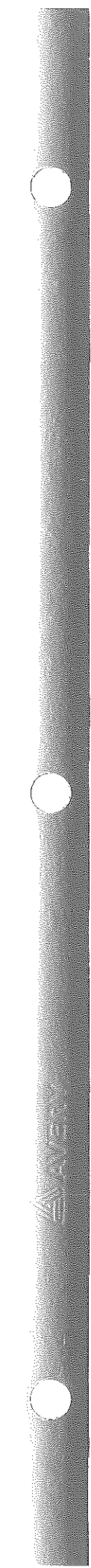

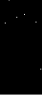
