**ORDER APPROVING 100% DISTRIBUTION TO APPROVED AND FINALIZED CLASS 2
CLAIMANTS OF THE ESTATE OF AMERICAN NATIONAL LAWYERS
INSURANCE RECIPROCAL (RRG), IN LIQUIDATION**

Before the Court is a Motion filed on September 28, 2012 by the Commissioner of the Tennessee Department of Commerce and Insurance ("Commissioner"), in her capacity as Liquidator of American National Lawyers Insurance Reciprocal (RRG) in Liquidation ("ANLIR") and the ANLIR Special Deputy Receiver requesting approval to distribute 1) the remaining 50% of numerous approved and finalized ANLIR Class 2 Claims, such that as a result of that payment, 100% of those approved and finalized ANLIR Class 2 Claims will have been paid and 2) 100% of two recently approved and finalized ANLIR Class 2 Claims that heretofore have had no interim distribution paid upon them.


There have been no objections or oppositions filed in relation to the pending Motion. Upon review of the Motion and upon the record in this proceeding as a whole, the Court finds the Motion well taken.

Accordingly, the Court approves, as to those ANLIR Class 2 Claims which had previously received a 50% interim payment, distribution of the amounts listed in **Exhibit A** to this Order in the column entitled "Remaining Distribution Approved for Payment," the aggregate amount being \$10,959,968.75. The Court also approves distribution of the amounts listed in **Exhibit B** to this Order in the column entitled "Total Distribution Approved for Payment," in the aggregate amount of \$500,000.00, said payments being as to two recently finalized and approved ANLIR Class 2 Claims which have not received previous interim payments. The Court also acknowledges and accepts the listings set forth in **Exhibits A and B** to this Order as the ANLIR Liquidator's report of Class 2 Claims which are final and ready for the distribution payments approved herein. T.C.A. § 56-9-331.

In their September 28, 2012 Motion, the Commissioner and ANLIR Special Deputy Receiver request, pursuant to Rule 54.02 Tenn. R. Civ. P., that the Order entered in relation to the Motion be entered as a final order in relation to all matters addressed therein. The Court finds that this Order does not address all matters involved in the ANLIR Liquidation proceeding. The Court further finds that the ANLIR Special Deputy Receiver will rely upon the rulings contained in this Order in taking actions such as payment of the distributions as approved herein. In doing so, the ANLIR Liquidation Estate needs certainty as to the Court's rulings. For that reason, and there being no just reason for delay, the Court expressly instructs the Clerk and Master to enter this Order as a final order as to all matters contained herein. Rule 54.02 Tenn. R. Civ. P.




