[PROPOSED] ORDER ACCEPTING AND APPROVING ENUMERATED CLAIMS AS DETERMINED IN THE DOCTORS INSURANCE RECIPROCAL, RRG LIQUIDATION ESTATE AND APPROVING PAYMENT FOR CERTAIN CLASS 2 CLAIMS

Before this Court is a Motion filed on November 30, 2015 by the Commissioner of the Tennessee Department of Commerce and Insurance, in her capacity as Liquidator of Doctors Insurance Reciprocal (RRG) in Liquidation ("DIR"), through her appointed Special Deputy Receiver. The Motion requests the Court accept and approve the determination of numerous claims submitted in the DIR Liquidation proceedings. Attached as **Exhibit A** to this Order is a listing of three (3) claims which the Special Deputy Receiver requests be accepted and approved as Class 2 claims. As to those three (3) claims, the Special Deputy Receiver also requests that 100% payment of the approved claim amounts be made upon this Order becoming final. Attached as **Exhibits B and C** to this Order are the listing of finalized Class 6 claims (Exh. B) and the listing of finalized Class 7 claims (Exh. C). From DIR's pending Motion, the Court understands that while acceptance and approval of the Class 6 and Class 7 claims set forth in **Exhibit B** and **Exhibit C** are sought, the Commissioner / DIR Special Deputy Receiver do not

seek approval of any payment of those approved claim amounts, pro rata or otherwise. Any payment, pro rata or otherwise, of those listed Class 6 and Class 7 claim amounts will occur only upon further motion to, and order of, the Court.

There have been no objections or oppositions filed in relation to the pending Motion.

Upon review of the Motion and upon the record in this proceeding as a whole, the Court finds the Motion well taken.

Accordingly, the Court approves the Class 2 claim amounts listed in **Exhibit A** to this Order in the column entitled "RRAO Determined Value" which aggregates to the amount of \$48,756.58. The Court also acknowledges and accepts the listings set forth in **Exhibit A** to this Order as the DIR Liquidator's report of those Class 2 claims which are final. T.C.A. §56-9-331. The Court also approves payment of these Class 2 claim amounts upon this Order becoming final.

The Court also approves the Class 6 and Class 7 claim amounts listed in **Exhibit B** and **Exhibit C**, respectively, said amounts appearing in the column entitled "RRAO Determined Value" to **Exhibit B** and **Exhibit C** to this Order. The Court also acknowledges and accepts the listings set forth in **Exhibit B** and **Exhibit C** to this Order as the DIR Liquidator's report as to those Class 6 and Class 7 claims which are final. T.C.A. §56-9-331. Distribution or payment, pro rata or otherwise, as to these Class 6 and Class 7 approved claim amounts will await further order of the Court.

In their November 30, 2015 Motion, the Commissioner and DIR Special Deputy Receiver request, pursuant to Rule 54.02 Tenn. R. Civ. P., that the Order entered in relation to the pending Motion be entered as a final order in relation to all matters addressed herein. The Court finds that this Order does not address all matters involved in the DIR liquidation proceeding. The Court further finds that the DIR Special Deputy Receiver will rely upon the rulings contained in

this Order in taking actions such as ultimate payment, pro rata or otherwise, of the claims approved herein. In doing so, the DIR Liquidation Estate needs certainty as to the Court's rulings. For that reason, and there being no just reason for delay, the Court expressly instructs the Clerk and Master to enter this Order as a final Order as to all matters contained herein. Rule 54.02 Tenn. R. Civ. P.

Finally, given the broad notice provided in relation to the Motion (see November 30, 2015 Motion at pp. 4-5) and given the lack of objections to the Motion and no appearance in opposition at the noticed December 18, 2015 hearing of the Motion, the Court deems it sufficient notice to those affected for the Order, once entered, to be posted on the Tennessee Department of Commerce and Insurance website at http://www.tn.gov/insurance/companyactions.shtml. The DIR Special Deputy Receiver is instructed to post this Order in that fashion as soon as is practicable after entry.




