ORDER ADOPTING EXAMINATION REPORT

Code Ann. § 56-1-401 *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance ("Division") has examined certain affairs of Centerline Property and Casualty Insurance Company ("Company"), an insurance company domiciled in the State of Tennessee. 1. The Company is **DIRECTED** to comply with Tenn. Comp. R. & Regs. 0780-01-67 by following the instructions for Form B and C filings and disclosing material related party transactions.

2. The Company is **DIRECTED** to comply with Tenn. Code Ann.

§ 56-11-106(a)(2) by making the required filings at least thirty (30) days prior to

the effective date of the agreements or modifications.

3. The Company is **DIRECTED** to comply with Tenn. Code Ann.

§ 56-2-104(a)(5)(A) by taking appropriate action to come into compliance

regarding the Company's principal place of business being located outside the

State of Tennessee.

The Company shall comply with the Directives contained in this Order within thirty (30)

days of its entry and execution.

The adoption of this examination report shall not preclude the Department from imposing

sanctions against the Company for potential violations of the Tennessee insurance law which

may be revealed in the examination report, it being the intent of this Order Adopting

Examination Report merely to adopt the examination report filed by the examiner-in-charge.
