## ORDER ADOPTING EXAMINATION REPORT

Pursuant to Tenn. Code Ann. §§ 56-1-401 *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance ("Division") has examined certain affairs of Citizens Mutual Insurance Company of Lincoln County, TN ("Company"), an insurance company domiciled in the State of Tennessee. As a result of an examination conducted as of December 31, 2016, the examiner-in-charge filed a verified, written report on the examination with the Division on April 2, 2018. A copy of that report was sent to the Company. (The Report on Examination of Citizens Mutual Insurance Company of Lincoln County, TN is attached hereto and marked as Exhibit A.) The Division received a response regarding the report from the Company on May 22, 2018. (The written response submitted by the Company is attached hereto and marked as Exhibit B.)

Pursuant to Tenn. Code Ann. § 56-1-411, the examination report regarding the affairs of the Company filed with the Division on April 2, 2018, is hereby **ADOPTED** as filed with the following **DIRECTIVES**:

- 1. The Company is **DIRECTED** to formalize its verbal agreements made with service providers by reducing the verbal agreements to writing.
- 2. The Company is **DIRECTED** to comply with Tenn. Code Ann. § 56-6-106(b) by discontinuing the practice of acting as an insurance producer.

3. The Company is **DIRECTED** to discontinue the practice of accepting premium payments for Farmer's liability policies in the same check as payment of its premiums.

4. The Company is **DIRECTED** to comply with Tenn. Code Ann. § 56-6-113(b) by discontinuing the practice of accepting commissions on Farmers' liability policies.

The company shall comply with the Directives contained in this Order within thirty (30) days of its entry.

The adoption of this examination report shall not preclude the Department from imposing sanctions against the Company for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report merely to adopt the examination report filed by the examiner-in-charge.
