ORDER ADOPTING EXAMINATION REPORT AS FILED



Code Ann. § 56-1-401, *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (hereinafter referred to as the "Division") has examined certain affairs of Plateau Casualty Insurance Company (hereinafter also referred to as the "Company"), an insurance company domiciled in the state of Tennessee. As a result of an examination conducted as of the 31st day of December, 2009, the examiner-in-charge filed with the Division, on the 6th day of May, 2011, a verified, written report on examination, and a copy of that report has been sent to the Company. (The Report on Examination of the Plateau Casualty Insurance Company is attached hereto and marked as Exhibit A). The Division did not receive a written rebuttal to said examination report.

Pursuant to Tenn. Code Ann. § 56-1-411, said examination report regarding the affairs of Plateau Casualty Insurance Company, filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the 6th day of May, 2011, is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Division from imposing sanctions against the Company for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report as Filed merely to adopt the examination report filed by the examiner-in-charge.


