## ORDER ADOPTING EXAMINATION REPORT

1. The Consortium is **DIRECTED** to amend its plan document to incorporate language that is in accordance with Tenn. Code Ann. § 56-7-2302(c)(2) and Tenn. Comp. R. & Regs. 0780-01-34-.04.

The Consortium shall comply with the Directives contained in this Order within thirty (30) days of its entry.

The adoption of this examination report shall not preclude the Department from imposing sanctions against the Consortium for potential violations of the Tennessee insurance law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report merely to adopt the examination report filed by the examiner-in-charge.
