Code Ann. §§ 56-1-401 *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (“Division”) has examined certain affairs of Tennessee Insurance Guaranty Association (“Association”), an insurance company domiciled in the State of Tennessee. As a result of an examination conducted as of December 31, 2016, the examiner-in-charge filed a verified, written report on the examination with the Division on December 29, 2017. The adoption of this examination report shall not preclude the Department from imposing sanctions against the Association for potential violations of the Tennessee Code Annotated, Title 56, which may be revealed in the examination report, it being the intent of this Order Adopting

Examination Report merely to adopt the examination report filed by the examiner-in-charge.
