ORDER ADOPTING EXAMINATION REPORT

Pursuant to Tenn. Code Ann. § 56-1-401 *et seq.*, the Insurance Division of the State of Tennessee, Department of Commerce and Insurance ("Division") has examined certain affairs of TRH Health Insurance Company ("Company"), an insurance company domiciled in the State of Tennessee. As a result of an examination conducted as of December 31, 2020, the examiner-in-charge filed a verified, written report on the examination with the Division on April 4, 2022. A copy of that report was sent to the Company. (The Report on Examination of the Company is attached hereto and marked as Exhibit A).

The Division received a response regarding the report from the Company dated June 24, 2022. (The written response submitted by the Company is attached hereto and marked as Exhibit B).

Pursuant to Tenn. Code Ann. § 56-1-411, the examination report regarding the affairs of the Company is hereby **ADOPTED** as filed with the following **DIRECTIVES**:

The Company should comply with Tenn. Comp. R. & Regs. 0780-01-37-.06, which
requires the Company to file its annual statements pursuant to the NAIC Instructions
for Completing Life and Accident and Health Annual Statement Blank. Such

statements are required to include complete financial and actuarial reporting

information.

2. The Company should comply with Tenn. Code Ann. § 56-8-104(11) by ensuring

compliance with applicable standards, rules and regulations for the documentation of

complaints, grievances, and appeals including that complaints, grievances, and

appeals are properly recorded.

The Company shall comply with the Directive contained in this Order within thirty (30)

days of its entry and execution.

The adoption of this examination report shall not preclude the Department from imposing

sanctions against the Company for potential violations of Tennessee insurance law which may be

revealed in the examination report, it being the intent of this Order merely to adopt the

examination report filed by the examiner-in-charge.
