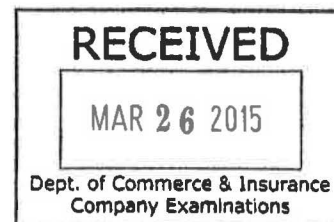
**ORDER ADOPTING EXAMINATION REPORT**


The adoption of this examination report shall not preclude the Department from imposing sanctions against U.S. Legal Services, Inc. for potential violations of the Tennessee Insurance
