Rule Changes Which Affect Licensees and Candidates

On June 24, 2012 several changes in the Tennessee State Board of Accountancy Rules became effective. Some of those changes related to already licensed CPAs and others related to candidates for licensure.

Rule Changes Related to Licensees:

Ethics CPE – Changed the biennial requirement from a total of 4 hours with at least 1 being State Specific to a total of 2 hours with both being State Specific. Licensees renewing in 2012 may satisfy the Ethics CPE Requirement with either the 4 hours with at least one state specific hour or only 2 hours with both being state specific hours. Please note: the ethics requirement is for the 2 year licensing period and is not an annual requirement.

Penalty for Late Renewal of License – Changed from two \$50.00 penalties (one applied February 1 following license

Firm Permit Renewal - Avoid CONFUSION

Each year a Tennessee CPA Firm must renew its permit. For firms that are sole proprietorships with NO CPA employees, the task is a fairly easy one. The Resident Manager accesses the permit renewal process at https://apps.tn.gov/cirens and does the following:

- Checks the contact information in the file to make sure all contact information is correct. If any information is not correct, changes can be made during the license renewal process.
- 2. Answers several questions concerning the firm.
- 3. And, makes payment (make sure receipt is printed when prompted to do so that's the only time it is available)

IT'S THAT SIMPLE for sole proprietorships WITHOUT CPA employees – meaning there is only one CPA on the premises and that CPA is the Resident Manager of the firm.

If the firm is anything other than a Sole Proprietorship With No CPA Employees (examples are sole proprietorship with one or more CPA employees, partnership, corporation, LLC, PLLC, etc.), the process involves one additional step. The Resident Manager of the firm must complete the Firm Ownership Form consisting of 4 sections.

- Section 1 Listing of CPA Owners
- Section 2 Listing of Owners who are not CPAs
- Section 3 Listing of CPA Employees (those who are not owners)
- Section 4 Listing of other states where the firm is permitted/licensed

If any section is not applicable, that section should be completed by stating in that section "Not Applicable" or "N/A".

The completed form should be mailed to the Board's office or scanned and e-mailed to Patricia.A.Turner@tn.gov or faxed to 615-532-8800 at the same time the payment for the renewal fee is made.

ATTENTION Resident Managers

The Application for obtaining a Tennessee CPA License by the process of reciprocity has changed. The new application requires the applicant complete the process with one application presentation and a \$200.00 application fee while the old application required the applicant present two separate applications with a \$100.00 application fee submitted with each paper form.

The new application for reciprocity applicants may be accessed at the Board's Web-Site http://www.tn.gov/commerce/boards/tnsba by first clicking on "Forms and Downloads" and then selecting "Application for Reciprocity" in the Application Section.

Please destroy any copies of the two part reciprocity application and have all reciprocity licensure candidates use the new one-part reciprocity application.

expiration and the other applied April 1 following license expiration) to one \$100.00 penalty applied February 1 after license expiration.

Interstate Practice – Clarifies that any person ever having had a Tennessee CPA License who now lives in and has an active CPA license in that other state must have his/her Tennessee CPA license in good standing in order to render CPA services in Tennessee under the Tennessee Mobility Statute. If the Tennessee CPA license is Expired, Delinquent, Suspended or Revoked the individual cannot practice in Tennessee using the Mobility Statute. Good standing statuses in Tennessee are Active, Inactive, Retired or Closed.

Firms – Removes the requirement that each firm location must have a peer review and adds the requirement that all firms providing attest services must enroll in an approved peer review program within 30 days of the date of the firm's initial licensure or within 30 days of providing the initial attest service (for already licensed firms).

Address Changes – Licensees have always been required to notify the Tennessee State Board of Accountancy of any address changes (mailing, home and work) within 30 days of such change. These new rules require that changes in e-mail addresses must also be provided to the Board's office within 30 days of such change.

Rule Change Related to Licensure Candidates:

Pre-License Accounting Education – Candidates who were not already approved to sit for the Tennessee CPA examination on 6/24/2012 must now complete 30 semester hours of Accounting Education (at least 24 of those hours must be in upper division accounting courses) in order to be approved to sit for the Tennessee CPA examination.

CPAs - It's time to renew again...

It's autumn – it's football season and the holidays are fast approaching. Do you know the other important date that is sneaking up on you? That's right – it's time to renew your license to practice public accountancy in the state of Tennessee!!

This is 2012, so it's the year for all of you licensees who hold an even-numbered license to go online and renew. By now, you should have received your renewal postcard in the mail giving detailed instructions on how to properly renew your license. But, just in case you've misplaced your postcard, here's what you do!



Go online to http://apps.tn.gov/cirens/ and key in your license number. You will also be asked to key in a ZIP code – please use the ZIP that appears on this newsletter! Then go on and answer the questions – then input your credit card information - and be sure to print out a receipt for your payment once your payment has been accepted. This is the only chance you get to print a receipt.

If you currently hold an active Tennessee CPA license and have not or will not meet the CPE requirements on or before 12-31-2012, you may want to inactivate your license. The form to inactivate your license is located on Page 12 of this newsletter.

Not sure if you are due to renew? Look at your wall certificate! If your license number ends in a 0, 2, 4, 6 or 8, then your license will expire on December 31st. So, get busy, get online and renew now! Give yourself the peace of mind by knowing that you've renewed early and you have protected your license.

If you determine you do not wish to renew your license, please close it properly in order to avoid disciplinary action taken against your license. The affidavit for closure/surrender of your license is located on Page 14 of this newsletter.

RECIPROCITY REMINDER

A Tennessee CPA license gained through reciprocity does not replace a license held in another state. You must still maintain or close that license in accordance with that Board's guidelines. Abandoning, or failing to renew, a license held in another jurisdiction may be grounds for disciplinary action by the Board.
