AMENDMENT 1 OF GRANT CONTRACT 54821

This Grant Contract Amendment is made and entered by and between the State of Tennessee, Department of Economic and Community Development, hereinafter referred to as the "State" and West Tennessee River Basin Authority, hereinafter referred to as the "Grantee." It is mutually understood and agreed by and between said, undersigned contracting parties that the subject Grant Contract is hereby amended as follows:

- Grant contract grant contract section A.5 is deleted in its entirety and replaced with the new contract section A.5.
 - A.5. The Grantee shall adhere to the following deadlines for the project. In the event that the Grantee is unable to meet a deadline, the Grantee shall request an extension of such deadline from the State in writing no later than five (5) business days prior to the deadline. Deadlines may not be extended outside of the Term of this Grant Contract except by a contract amendment executed in accordance with Section D.2. of this Grant Contract.
