#### **Tennessee Parental Involvement Standards Overview**

- Tennessee Parental Involvement Standards Survey resulted from Senate Bill No. 293 that was enacted as a state law in 2009.
- Law required the Department of Education to develop parental involvement standards in public schools and report compliance information for each LEA and public school on the TDOE Report Card annually beginning with the 2010-11 school year. The law affects all public schools: non-Title I, charter schools, and Title I.
- The PTA standards are based on the PTA's National standards for Family-School Partnerships which were adopted by the State Board of Education on July 30, 2010.

### **Tennessee Parental Involvement Standards**

#### **Standard 1: Welcoming All Families:**

Families are active participants in the life of the school, and feel welcomed, valued, and connected to each other, to school staff, and to what students are learning and doing in class and school.

### **Standard 2: Communicating:**

Families and school staff engage in regular, meaningful communication about student learning.

### **Standard 3: Supporting Student Success**

Families and school staff continuously work together to support students' learning and healthy development both at home and at school, and have regular opportunities to strengthen their knowledge and skills to do so effectively.

#### Tennessee Parental Involvement Standards

#### **Standard 4: Speaking Up for Every Child:**

Families are informed and enabled to be advocates for their own and other children, to ensure that students are treated fairly and have access to learning opportunities that will support their success.

### **Standard 5: Sharing Power:**

Families and school staff are equal partners with equal representation in decisions that affect students and families and together inform, influence, and create policies, practices, and programs.

### **Standard 6: Collaborating with Community:**

Families and school staff work together with community members to connect students, families, and staff to expanded learning opportunities, community services, and civic participation.

## **Tennessee PI Standards Survey**

#### Two surveys:

- District survey is to be completed by the Federal Programs Director or district Parental Involvement Coordinator.
- School survey is to be completed by the school Parental Involvement Coordinator or designee for each public school.
- Districts provide the public schools including charter schools the Survey Gizmo website and survey window to complete the survey. The survey window is April 11-23, 2014.
