Please find attached the summary review of findings from the School Nutrition Program's 2021-22 fiscal year administrative review of Montessori Elementary at Highland Park National School Lunch Program and School Breakfast Program. This review was conducted the week of April 4, 2022, with the exit date of April 6, 2022. The attached summary includes the identified findings and the corrective actions required.

District responses and supporting documentation of corrective actions are required for all findings, and findings must be corrected district wide. The School Nutrition Program director must provide the responses to the findings via the Tennessee: Meals, Accounting, and Claiming (TMAC) system in the "Compliance" section, as discussed with the lead reviewer. Technical assistance areas do not require responses; these suggestions are only to help the district improve the program. They are also available in the "Compliance" section in TMAC.

All corrective actions shall be documented and supported in the "Compliance" section in TMAC no later than March 3, 2022. During this timeframe, if you find errors or points of disagreement in our findings, please contact me, to discuss next steps. If there are no errors or points of disagreement, please be mindful that refusal or failure to comply with the required, corrective actions within the allotted timeframe may result in potential fiscal action.

Upon receipt Montessori Elementary at Highland Park documented corrective action, the Tennessee Department of Education will determine whether the documentation is complete and resolves the findings identified. Once the department approves the corrective actions, your district will receive a closure letter closing the review within 30 calendar days.

1400 - Food Safety	V-1400	Observed on-site storage violations.	Retrain staff on proper procedures for the receiving and storage of food in dry storage, refrigeration and freezer storage. Upload agenda and sign-in sheets to demonstrate compliance has been trained.
500 - Offer versus Serve	V-0500	Observed that the cafeteria staff had not been trained on Offer Versus Serve (OVS).	Provide Offer Versus Serve training to cafeteria staff and upload an agenda and sign in sheet for documentation of compliance.
1400 - Food Safety	V-1400	Observed selected relevant temperature logs were not available for review.	Retrain cafeteria staff on proper temperature logging procedures; attach an agenda and sign-in sheets of trainees as documentation that this training has occurred. 500 - Offer versus Serve	V-0500	(OVS) was not properly	Retrain staff on the proper implementation of Offer Versus Serve. Upload agenda and sign in sheets from training as evidence of compliance.
1400 - Food Safety	V-1400	plan was not properly	Update and provide a copy of a revised comprehensive food safety plan to include the regulatory items required by 7CFR 210.13.
