Please find the attached summary review of findings from the School Nutrition Program's 2023-24 fiscal year administrative review of Milan Special School District's National School Lunch Program and School Breakfast Program. This review was conducted the week of April 10, 2024, with the exit date of April 12, 2024. The attached summary includes the identified findings and the corrective actions required.

District responses and supporting documentation of corrective actions are required for all findings, and findings must be corrected district wide. The School Nutrition Program director must provide the responses to the findings via the Tennessee: Meals, Accounting, and Claiming (TMAC) system in the "Compliance" section, as discussed with the lead reviewer. Technical assistance areas do not require responses; these suggestions are only to help the district improve the program. They are also available in the "Compliance" section in TMAC.

All corrective actions shall be documented and supported in the "Compliance" section in TMAC no later than May 13, 2024. During this timeframe, if you identify errors or points of disagreement in our findings, please contact me to discuss next steps. If there are no errors or points of disagreement, please be mindful that refusal or failure to comply with the required, corrective actions within the allotted timeframe may result in fiscal action.

Upon receipt Milan Special School District's documented corrective action, the Tennessee Department of Education will determine whether the documentation is complete and resolves the findings identified. Once the Department approves the corrective actions, your district will receive a closure letter closing the review within 30 calendar days.

At least once every three years, the following is measured and made available to the public: • the extent to which schools comply with the LWP, • the extent to which the LWP compares to model local school wellness policies, and • the progress made in attaining the goals of the LWP The policy must include standards for all foods and beverages provided, but not sold, to students during the school day (e.g., in classroom parties or classroom snacks brought by parents). The policy must include requirements for marketing and advertising of only those foods and beverages that meet the USDA Smart Snacks in School nutrition standards on the school campus during the school day.
