SUBJECT: School Year 2020-21 Safe Schools Report

The Schools Against Violence in Education (SAVE) Act of 2007, now codified as T.C.A. §49-6-801-816, provides that the commissioner of education annually report to the governor and General Assembly on implementation of the Act. Additionally, T.C.A. § 49-6-4301 requires the commissioner to report on "the prevalence of violent and disruptive incidents in the public schools, and the effectiveness of school programs undertaken to reduce violence and assure the safety and security of students and school personnel."

The attached report provides a summary of serious incidents occurring within Tennessee schools during the 2020-21 school year, as well as an overview of efforts currently undertaken to ensure the safety of our students and staff.

Executive Summary

T.C.A § 49-6-810 requires the commissioner of education to report annually to the Governor and General Assembly on implementation and compliance with the Schools Against Violence in Education (SAVE) Act. Additionally, T.C.A. § 49-6-4301 requires the commissioner to report on "the prevalence of violent and disruptive incidents in the public schools, and the effectiveness of school programs undertaken to reduce violence and assure the safety and security of students and school personnel." The 2020-21 school year brought about new challenges with the COVID-19 pandemic, and school safety expanded supports to schools.

As the COVID-19 emergency unfolded across Tennessee communities, the value of a community-focused, multi-hazard approach to school safety planning became apparent. By taking advantage of pre-existing agreements and relationships, partnerships were further solidified throughout the 2020-21 school year. The department's partnership with the Tennessee Emergency Management Agency (TEMA) has been instrumental in providing over 2,000 shipments of personal protective equipment (PPE) and critical cleaning/disinfecting supplies to Tennessee's public and private schools. Support from the department of health has enabled our school leaders to have direct access to the information and support needed to make difficult decisions regarding school operations. Perhaps most importantly, these partnerships are mirrored locally with county emergency management agencies and health departments.

While the pandemic created unique obstacles, important school safety functions were continued. This included the disbursement of annual Safe Schools funding, training of school safety personnel, and increased presence of school resource officers in Tennessee schools.

Emergency Preparedness

Emergency Operation Planning

The SAVE Act, passed in 2007, established specific and consistent requirements for districts related to providing a safe school environment, including the formation of district and school safety teams and requirements for the development of comprehensive safety plans. These plans, referred to as emergency operation plans (EOPs), outline how schools prepare for, respond to, and recover from emergencies. A well-developed and well-documented EOP

ensures that plans and procedures are comprehensive and are communicated to everyone with a potential role during emergency situations.

It is important to note here the difference between a district and a school EOP. District EOPs set the stage for school-level EOPs by providing standards and, where appropriate, uniform response protocols. District EOPs also ensure that adequate and appropriate planning occurs with the broader school community and that district-level resources will be directed to support schools when needed. School-level EOPs provide the individually tailored planning, support and direction needed to address the unique needs of each school.

District and school EOPs are reviewed by an interdepartmental team on a <u>five-year cycle</u> that coincides with their county emergency management planning cycle. The team is comprised of representatives of the Tennessee Departments of Education, Health, Commerce and Insurance, Safety and Homeland Security and the Tennessee Emergency Management Agency. EOP reviews are conducted using an evaluation rubric that is aligned with EOP requirements identified in T.C.A § 49-6-805.

During the 2020-21 school year, 29 district EOPs were reviewed with the following findings:

Conducting Emergency Drills

Training on school safety principles provides school personnel techniques for identifying strategies to prevent or mitigate threats and hazards, respond to emergencies and to ultimately recover from a crisis. Students are trained on emergency procedures, and emergency drills provide an opportunity to identify gaps in the training. The current drill requirements for schools are outlined in the table below:

Drill	Description
Fire Drill	Fire drills requiring full evacuation shall be held at least one (1) time every thirty (30) SCHOOL DAYS , with two (2) fire drills occurring during the first thirty (30) full days of the school year. Additionally, four (4) fire safety educational announcements will be conducted throughout the year. T.C.A. § 68-102-137.
Intruder Drill	Each school shall conduct at least one (1) armed intruder drill annually. The drill shall be conducted in coordination with the appropriate local law enforcement agency. T.C.A. § 49-6-807.

In addition to reviewing EOPs, 2019-20 school year drill logs were also reviewed. Although the school year was disrupted by the pandemic, schools were able to conduct many of the required drills prior to closing. 299 drill logs were reviewed during the most recent review cycle indicating the following:

School Resource Officers

The 111th General Assembly amended T.C.A § 49-6-809 to prioritize the placement of school resource officers in Tennessee schools. For FY20, the General Assembly appropriated an additional \$20 million in one-time Safe Schools funding to support the placement of school resource officers (SROs) in schools across the state that did not have a full-time officer in place during the previous school year.

During the 2019-20 school year, the department awarded \$7,466,700 for 213 new, full-time SROs in 57 LEAs. The 57 LEAs awarded funding during the 2019-20 school year were allowed to apply for a second year of funds and 51 of those LEAs reapplied. During the 2020-21 school year, the department awarded \$6,811,378 to support 195 school resource officers during the 2020-21 school year. Six LEAs did not reapply as their partner law enforcement agency was unable to recruit or place an officer within the current pandemic environment.

The department will continue to work closely with the Department of Safety and Homeland Security to identify strategies to increase SRO placement with grant funds. Information about school resource officer grant funding can be found in <u>Appendix I</u>.

The table below reflects a four-year trend in the number of SROs and the percentage of SROs at each grade band in schools.

School Safety Grant Programs

The Tennessee Department of Education (department) currently administers two grant programs to support school safety—the Safe Schools Grant and the School Resource Officer (SRO) Grant.

Grant Program Overviews

Safe Schools (Recurring)

• **Purpose:** Districts are required to use the results of a school security assessment developed by the Department of Safety and Homeland Security as a needs analysis to drive the use of grant funds. Alignment with identified needs is validated during the grant approval process. Information about district level funding, including how these funds are being utilized can be found in <u>Appendix II</u>.

• **Awards:** Grants are awarded to all districts in proportion to their relative share of the BEP formula. Districts are required to provide a 25% local match that is adjusted for fiscal capacity.

Appropriations:

FY18: \$4.8M in recurring funding

FY19: \$10M in recurring funding

FY20: \$20M in recurring funding

o FY21: \$20M in recurring funding

SRO Grant(Non-Recurring)

- **Purpose**: Grant funds are limited to supporting the placement, training, or equipment for full-time SROs in schools that did not have a full-time SRO in the prior year.

 Information about district level funding can be found in Appendix II.
- **Awards:** Any Tennessee school district may apply. Grants are in the amount of \$35,000 per SRO and require a 25% local match that is adjusted for fiscal capacity.
- **Appropriation:** The grant program was set up for two years with the non-recurring FY20 appropriation of \$20M in Safe Schools funding. Both grant program years are supported with this one-time appropriation.

Grants to States for Emergency Management

In October 2018, the department was awarded a five-year U.S. Department of Education grant for the purpose of expanding the state's capacity to assist schools in the development and implementation of high-quality emergency operations plans (EOPs). During the 2020-21 school year, the following objectives were addressed:

Objective A: Expand training and support to LEAs through staffing infrastructure within the department, as well as contractual support, to enable the Tennessee School Safety Center to

transition to a force multiplier model via the use of training of trainers to reach a larger and more diverse target population.

- The department has hired a full-time School Safety Planning Coordinator who has participated in the following trainings throughout the year.

- We also have 10 School Safety Mentors who are trained trainers in Developing High-Quality EOPs, Reunification, Psychological and Emotional Recovery, PREPARE
 Postvention, Active Shooter training and Threat Assessment. This year, the trainers have fine-tuned these professional learning sessions to consider issues around our current pandemic. Each professional learning session offered by the School Safety Mentors aligns with the emergency operations planning template and incorporates a review or revision to those specific areas of the participant's EOP.

- o **Training Evaluations** indicate the following:
 - 96.5% of participants Agree or Strongly Agree that the content from the session covered information they anticipated learning.
 - 93.8% of participants Agree or Strongly Agree that the session enhanced their knowledge or skills.
 - 95% of participants Agree or Strongly Agree that the instructor's presentation skills were approachable, clear, and effective.
 - 95.5% of participants Agree or Strongly Agree that the training would be beneficial to others in the future.
- o **Comments** from the training evaluations include the following:
 - "Thank you for funding the safety mentor position. I realize our county is ahead in some areas. However, we have new central office staff and multiple new school administrators throughout our county. It is wonderful to have a point of contact that is so knowledgeable and willing to answer questions anytime."

- A **needs assessment survey** conducted in February 2021 with each LEA's Safe Schools Coordinator indicated the following needs or requests:

 - o 20 LEAs requested training in Security Practices and Crime Prevention through Environmental Design (CPTED)
 - o 27 LEAs requested training in Physical Security Assessments
 - o 35 LEAs requested training in Threat Assessment
 - 24 LEAs requested assistance in School Resource Officer Standards,
 Qualifications, Training and MOUs
 - o 25 LEAs requested assistance in Suicide Prevention
- While our Safety Mentors have been working to meet these requests, we have
 collaborated with our Department of Safety and Homeland Security to develop a video
 training, "Crime Prevention Through Environmental Design (CPTED) Security Practices
 and Assessments," that aligns with the physical security section of the district and school
 emergency operations templates. The video training was released to all LEAs to be
 conducted by all school administrators on March 17, 2021. As of September 30,2021,
 1,800 schools from 147 districts have completed the video training and we have
 received the following feedback:
 - o 99% of participants stated that they Strongly Agree or Agree that the video training enhanced their knowledge and/or skills.
 - o 99% of participants stated that they Strongly Agree or Agree that the training would be beneficial to others in the future.
 - o Participant feedback included the following comments:
 - "Very good training. Very good refresher also for those of us that have had CPTED."
 - "Great training. Video was easy to follow, and the presenter was excellent and clear to understand."
 - "This training was very informative with detailed information that provided strategies to improve our school security."
 - "This video was informative and gave me more information of our school's appropriate security level and how to keep our kids safe."
 - "Great presentation with material that can be put in place for effective management of schools at any level."

Objective B: Create training, curriculum and technology supports that enable LEAs to effectively monitor and support the development of building level-EOPs.

- A Safety Training Curriculum Development and Delivery contract was executed with the following objectives:
 - 1) Training curriculum based on national and state policy and best practices in a variety of formats to include an instructor guide for the school safety mentors to present from. These trainings will enable district level and school level administrators as well as school level staff to understand their role in school safety, security, intervention, prevention, and emergency preparedness planning.
 - 2) Continuation and improvements to the Tennessee School Safety Mentor Program, which represent diverse areas of experience and expertise, located throughout each grand division, who will be available to assist districts in meeting needs identified through the security assessment and compliance monitoring processes in place or currently being developed.
 - 3) Revision and launch of the Tennessee School Safety Specialist (TSSSP) program which incorporates the elements described above and is focused upon establishing a cadre of trained school personnel across the state.

- 4) Training evaluations aligned with established State and federal training evaluation and reporting requirements.
- 5) It is the department's intent that the three support elements identified above shall interface in such a way as to support the broad dissemination of best practices in school emergency operations and long-term sustainability.
- 6) That procurement plan was approved on March 17, 2021, and we have been approved to post our Request for Applications on May 1st with execution of contract on August 15, 2021.

Objective C: Define the role of the school resource officers and the first responder community in assisting schools in the development of building level EOPs and develop training and resources to support that role.

- Although unable to meet in person due to the COVID-19 pandemic, the school safety team has remained collaborative with law enforcement partners through the use of virtual meetings.
- The school safety team has worked with our state procurement team on a contract for SRO training that includes development of a 40-hour basic training course for new SROs and a 16-hour training course for annual STO training. That procurement plan was approved on February 4, 2021, and a Request for Applications was approved and posted on March 22, 2021. We held a pre-bidder meeting on March 26,2021. Applications were due on April 23, 2021, and the contract was executed on July 1, 2021. The training topics include:
 - o Engaging the School Community
 - o Working with Students with Special Needs
 - o Crisis Intervention
 - o Emergency Operation Planning
 - o Threat Assessments
 - o School Security Assessments
 - o Current Trends in Juvenile Crime and Contributing Factors
 - o Risk Management for After School and Interscholastic Athletics

Objective D: Research best practices and develop a framework or template for integrating student transportation operations into district and school-level EOP processes and create training resources for transportation supervisors and drivers.

- We are in the process of developing a Student Transportation Safety Plan to include the following:
 - o Preparedness
 - Inspections
 - Communications
 - Emergency Kits
 - Emergency Drills
 - o Response
 - Functional Procedures to include Shelter in Place, Drop Cover and Hold,
 Evacuation Procedures, and Student Accountability and Release
 Procedures
 - Threats and Hazards to include Critical Medical Emergency, Non-Critical Medical Emergency, Bus Transfer, Fire, Collision or Crash, Downed Power Lines
- The school safety training contract will include the development of training for bus drivers that is aligned with the student transportation safety plan.

Objective E: Maintain a partnership infrastructure that will facilitate collaboration and ensure sustainability beyond the grant period.

- We have developed a formal relationship with Commerce and Insurance to ensure the accountability of our drills.
- We have developed a formal relationship with Tennessee Emergency Management Agency (TEMA) to collaborate on emergency preparedness for schools, and to coordinate response for school emergencies.
- We have developed informal relationships with Tennessee Department of Safety and Homeland Security for development, training, and monitoring of school security assessments.
- We have also developed informal relationships with the Tennessee Department of Health and Tennessee Department of Mental Health for the development of resources and information.

Our goals for the remaining project year 4 are to:

- Develop Curriculum for the Tennessee School Safety Specialist Program. The purpose of the Tennessee School Safety Specialist Program is to provide ongoing training and information on national and state best practices, as well as exemplary resources for school safety, security, intervention and prevention, and emergency preparedness planning. Our anticipated outcomes are the implementation of school safety practices that promote the development of safe and supportive learning environments for all students and staff. Our goal is that each district will have a School Safety Specialist that will be responsible for the following responsibilities and activities:
 - o Coordinate the review, editing, and updating of Emergency Operation Plans for their district and schools each year as established under T.C.A. §§ 49-6-801-814
 - o Train school-level safety teams on the training, real-world use, and revision of emergency operations plans.
 - o Network with appropriate stakeholders to enhance school safety at the district or school level.
- Complete the Student Transportation Safety Plan for distribution to bus drivers and develop an accompanying training.
- Complete the development of school resource officer training that incorporates elements of emergency planning to include:
 - o Memorandums of Understanding
 - o Emergency Operations Planning
 - o Understanding and Working Effectively with Students with Special Needs
 - o SRO role in security and threat assessments.
- Develop Annex Additions for Emergency Operation Plans including:
 - o Continuity of Operations
 - o Long-Term Recovery
 - o Transportation

Transportation

Since implementation of T.C.A. § 49-6-2116,, the department has hired a director and a consultant to oversee training and monitoring associated with the new district transportation requirements. The department's transportation staff is responsible for overseeing support in training and compliance, and for recommending school bus specifications. Significant accomplishments in this area include:

- Training- Transportation supervisor training guidance has been developed and shared
 with LEAs to clarify the training process and supervisor obligations. Student
 Transportation Management Training has been developed and is currently being
 offered as on-demand courses for transportation supervisors. 142 supervisors
 completed annual ongoing training and 45 new supervisors completed initial supervisor
 training through the department's online courses in the 2020/2021 school year. All
 supervisor training is being tracked and certified.
- Compliance- A monitoring system is in place to ensure compliance with state and federal pupil transportation requirements. To date, 96 compliance visits have been completed.
- Specifications- The Tennessee State Board of Education approved updated school bus specifications based on the department's recommendations on September 18, 2019.
 The department is working toward conducting another update to Tennessee's school bus specifications in 2022.

In addition, the department is currently administering a \$3 million appropriation to establish a school bus seat restraint grant program. The program reimburses districts for the additional cost associated with adding seat restraints when purchasing new buses or retrofitting qualifying buses already in operation. Seventeen districts have been awarded grant funding to place 87 buses in service that are equipped with seat restraints.

Additional information regarding Tennessee's student transportation system and the seat restraint grant can be found in <u>Appendix III</u>.

School Safety Index

Serious incidents related to student behavior in Tennessee schools are tracked via the department's student management information system. For the purposes of this report, the department has developed a measure entitled the School Safety Index which includes those serious incidents deemed to be most directly related to the safety and welfare of students, including the following:

- Possession of a handgun
- Possession of a rifle or shotgun
- Possession of an explosive or incendiary device

The table below indicates serious incident totals for school years 2015-16 through 2020-21. Due to the significant reduction in the number of days in which students were on campus as a result of COVID-19 school closures, the data demonstrates a reduction in serious incidents. For that reason, the 2019-20 and 2020-21 data is not comparable.

In order to arrive at a school-level measure, the total number of the above incidents that have been reported for the school year via the student management information system are divided by a school's average daily membership (ADM) to arrive at a school safety index score. Scores for any schools reporting one or more serious incidents during the 2020-21 school year, aggregated by school district, are included in <u>Appendix IV</u>.

Using the same formula (i.e., serious incidents/ADM) to review Tennessee as a whole, the aggregate school safety index for Tennessee is presented below. Again, due to the significant reduction in the number of days in which students were actually on campus as a result of the COVID-19 pandemic school closures, 2019-20 and 2020-21 data is not comparable.

Road Ahead

As we navigate teaching and learning following the COVID-19 crisis, school safety will continue to be a priority. A particular focus for the 2021-22 school year includes school climate, threat assessment, and supporting school resource officer programs. Specific steps currently being taken include:

- 1) Development of school-level climate and threat assessment training and resources.
- 2) Establishing strong district and school-level leadership via a renewed focus on fundamental school safety and preparedness practices as operationalized through an updated Tennessee School Safety Specialist Program (TSSSP).
- 3) Support of the General Assembly's commitment to placing a school resource officer in every Tennessee school by continuing the grant program begun in FY 20 while expanding the availability of high-quality training for all SRO's.

Appendix III: Tennessee Student Transportation Summary

The Danger Zone Statistics

As cars on the road and distracted driving have both continued to increase, so too has the prevalence of danger zones around school buses. The number of cars on the streets grew by 12.8 million between 2017 and 2021. Distracted driving claimed 3,142 lives and injured 276,000 people in 2019. Sixty-five percent of illegal passing of school buses occur due to distracted drivers, while 35 percent occur because the driver did not know they had to stop. Tennessee bus drivers participate in an annual survey of illegal passing entitled *The Danger Zone*. Below are the results for the 2018 and 2019 survey.

Appendix IV: 2020-21 School Safety Index

Description: T.C.A. § 49-6-4301 states that "the commissioner shall report to the governor and the General Assembly concerning the prevalence of violent and disruptive incidents in public schools." To fulfill this legislative mandate, the department has developed the School Safety Index. For each school, the reported sum of serious school safety incidents is divided by the school's average daily membership (ADM) to arrive at a percentage of enrollment or School Safety Index score. A higher index score indicates a relatively higher level of reported incidents. Schools that did not report any of the serious incidents identified below will not appear in the index:

- Possession of a handgun
- Possession of a rifle or shotgun
- Possession of an explosive or incendiary device
- Possession of a weapon other than a firearm
- Assault of a teacher or staff member
- Assault of a student
- Sexual assault
- Aggravated assault of a teacher or staff member
- Aggravated assault of a student
- Attempted homicide
