HAZARDOUS WASTE MANAGEMENT CORRECTIVE ACTION PERMIT MODIFICATION FOR ARNOLD ENGINEERING AND DEVELOPMENT COMPLEX

The Tennessee Department of Environment and Conservation (TDEC) Division of Solid Waste Management (DSWM) has issued a hazardous waste modification to the hazardous waste management permit (Permit No. 179). The facility is located in Coffee and Franklin Counties at 100 Kindel Drive, Arnold Air Force Base, TN 37389-2322; EPA ID Number: TN8570024044. DSWM finalized this modification following a 45-day public comment period, which ended on August 7, 2023, and a public hearing held on July 10, 2023. Two members of the public attended the public hearing. No comments were received from the public during the comment period or the public hearing. DSWM has included a Response to Comments that describes the comment process as well as identifies editorial changes made by DSWM to the draft modification prior to issuance.

The Class 3 Modification included updating Attachment 9 – Table 9.1-1 and 9.1-6, by removing corrective action remedies at four Solid Waste Management Units (SWMUs), Attachment 4 – Table 4-1, Inspection Schedule for Container Storage Area, Attachment 5 – Personnel Training, and Attachment 6, Contingency plan, as well as other administrative changes.

Permit TNHW-179 was modified on September 7, 2023, under the authority of the Tennessee Hazardous Waste Management Act of 1977, as amended, Tennessee Code Annotated, Section 68-212-101 et seq., and Rule Chapter 0400-12-01, <u>Hazardous Waste Management</u>.
