## NOTICE OF MODIFICATION REQUEST TO HAZARDOUS WASTE CORRECTIVE ACTION PERMIT

Gardner Denver, Inc. is providing notice of the submittal of a Class 2 permit modification to the existing Hazardous Waste Corrective Action Permit TNHW-167 in accordance with Tennessee Rule 0400-12-01-.07(9)(c)(5)(ii). The facility TND006379200 is located in Washington County at 2003 South Roan Street, Johnson City, Tennessee, 37601.

The Class 2 modification was submitted on March 20, 2023, with a response to a notification of deficiency being received on May 12, 2023, to the Tennessee Department of Environment and Conservation, Division of Solid Waste Management in accordance with Tennessee Rule 0400-12-01-.07(9)(c)(5)(ii) to allow Gardner Denver to continue to perform post-closure care for the closed hazardous waste landfill at the former Thomas Industries site by adding an additional groundwater capture location to the on-site treatment system. The modification will also update the site history from recent investigations since the most recent permit renewal (updated soil boring logs, maps, and engineering drawings), add additional sampling points, and update contact information.

In accordance with Tennessee Rule 0400-12-01-.07(9)(c)(5)(ii)(IV), Strata Environmental Services, Inc. on behalf of Gardner Denver, Inc. will conduct a public meeting regarding the requested modification. The public meeting will be held on Monday, June 12, at 6:30 pm at Science Hill High School – Grand Topper Hall, 1509 John Exum Parkway, Johnson City, Tennessee.
