## NOTICE OF MODIFICATION REQUEST TO HAZARDOUS WASTE TREATMENT AND STORAGE PERMIT

Tradebe Treatment and Recycling of Tennessee, LLC is providing notice of the submittal of two (2) Class 2 permit modifications to the existing Hazardous Waste Permit TNHW-188 in accordance with Tennessee Rule 0400-12-01-.07(9)(c)(5)(ii). The facility is located at 5485 Victory Lane, Millington, Tennessee 38053, Shelby County, EPA identification number TND000772186.

A Class 2 modification was submitted on December 13, 2023, to the Tennessee Department of Environment and Conservation, Division of Solid Waste Management (DSWM) in accordance with Tennessee Rule 0400-12-01-.07(9)(c)(5)(ii) to allow of usage of the Unit 209 building for container storage, sampling, and treatment.

A second Class 2 modification was submitted on March 12, 2024, to the Tennessee Department of Environment and Conservation, Division of Solid Waste Management in accordance with Tennessee Rule 0400-12-01-.07(9)(c)(5)(ii) to update the tables in the Permit based on the confirmatory sampling completed for Solid Waste Management Unit (SWMU) 11. SWMU 11 is proposed to be moved from Table 10.1-2, List of Solid Waste Management Units and Areas of Concerns that Require Confirmatory Sampling to Table 10.1-1, List of Solid Waste Management Units and Areas of Concern that Require No Further Action Under the Corrective Action Conditions, at this time.

In accordance with Tennessee Rule 0400-12-01-.07(9)(c)(5)(ii)(IV), Tradebe Treatment and Recycling of Tennessee, LLC will conduct a public meeting regarding the requested modifications.
