## TRANSFER OF LANDFILL OWNERSHIP APPROVED FROM WAUPACA FOUNDRY, INC. TO PLTN HOLDINGS, LLC

PLTN Holdings, LLC has taken ownership of the Class II landfill at 294 County Road 516, Englewood, TN 37329 (latitude 35.3974 / longitude -84.5168). The Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM), approved a change of ownership for the Class II landfill pursuant to Rule 0400-11-01-.02(6)(a) of Tennessee's Solid Waste Program Processing and Disposal Regulations. PLTN Holdings, LLC applied for a minor permit modification to transfer the permit for the Thyssen Krupp Waupaca, Inc. Plant 6 Landfill (IDL540000100) from the previous owner, Waupaca Foundry, Inc. to PLTN Holdings, LLC. As part of this transfer of ownership, the facility name has changed from the Thyssen Krupp Waupaca, Inc. Plant 6 Landfill to the PLTN Holdings Landfill. The operator has changed from Waupaca Foundry, Inc. to PLTN Holdings, LLC. The final decision to issue the permit modification was made on Tuesday, December 19, 2023.
