2021 Annual Compliance Report

Foreword

The 1996 Amendments of the Federal Safe Drinking Water Act requires States with drinking water primacy to prepare and submit to EPA an annual report regarding public water system violations. Further, the report is to be published and made available for public review. The Tennessee Department of Environment and Conservation, Division of Water Resources, has prepared this report to provide the required information to EPA and to the general population.

This year's report covers the calendar year 2021 and contains three major sections: a narrative description of the Division's oversight of public drinking water systems; a summary of violations regarding each contaminant (Appendix A); and a detailed listing of public drinking water systems with violations meeting the criteria to be included in the report (Appendix B). Only treatment technique, maximum contaminant level and significant monitoring violations that have not returned to compliance (i.e. violations that have not been corrected) occurring within or extending into 2021 are included.

Most of the water systems and operators in Tennessee are very conscientious about the quality of water provided to their customers. However, situations do occur that result in monitoring violations caused by either an oversight on the part of the water utility or due to newly implemented monitoring requirements or standards. Most of the health-based violations that occurred during 2021 were identified in the disinfection by product rules, where compliance with the standards is location specific.

The Division has worked with water utility managers/owners and operators to address each of the violations included in this report. Site visits and technical guidance are the first steps utilized by the Division to achieve compliance with the regulations. In certain situations, it becomes necessary to initiate formal enforcement action and establish compliance schedules to have a system return to compliance.

The Division hopes this report provides violation information in a concise and easy to understand manner. Safe Drinking Water Act

The Federal Safe Drinking Water Act (SDWA) was enacted in 1974 in order to assure that the public is provided with safe drinking water. Pursuant to the Safe Drinking Water Act and Amendments to the Act, national limits or standards were established on contaminant levels in drinking water to ensure that drinking water is safe for human consumption. Such standards are known as Maximum Contaminant Levels (MCLs).

The SDWA also establishes treatment techniques, in lieu of maximum contaminant levels, for certain contaminants that are difficult for laboratories to measure. For example, treatment techniques have been established for giardia lamblia, cryptosporidium, viruses, heterotrophic bacteria, Legionella, and turbidity. In addition, the SDWA regulates how frequently public water systems must monitor and report the results of monitoring for contaminants that may be present in the drinking water, as well as the effectiveness of treatment processes.

A public water system is required to monitor and verify that the levels of contaminants present in the water do not exceed an established maximum contaminant level. If a public water system fails to monitor as required or fails to report monitoring results correctly, then a monitoring or reporting violation occurs. Generally, the larger the population served by a water system, more frequent monitoring and reporting is required. Additionally, the SDWA requires public water systems to notify the public when they have violated these regulations. The 1996 Amendments to the SDWA require public notification to include a clear and understandable explanation of the nature of the violation, its potential adverse health effects, the steps that the public water system is undertaking to correct the violation and the possibility of alternative water supplies.

The SDWA applies to all fifty (50) States and U.S. territories and allows States and Territories to seek EPA approval to administer their own Public Water System Supervision Program. The authority given to a state to operate a Public Water System Supervision Program is called "Primacy". In order to receive primacy, a state must meet certain requirements specified in the SDWA and regulations promulgated pursuant to the Act. The State of Tennessee received primacy in 1977 and assumes primary enforcement responsibility for public water systems operating in Tennessee.

Public Water Systems


The SDWA defines a "public water system" as a system for the provision of water for human consumption through pipes or other constructed conveyances, if such system serves fifteen (15) or more service connections or which regularly serves twenty-five (25) or more individuals daily at least sixty (60) days out of the year. A public water system includes:

- (i) Any collection, treatment, storage, or distribution facility under control of the operator of such system and used primarily in connection with such system; and
- (ii) Any collection or pretreatment storage facility not under such control which is used primarily in connection with such system.

The Division of Water Resources currently possesses regulatory responsibility for approximately 770 public water systems throughout the state. A "Public Water System", as defined above, is either a "community water system" or a "non-community water system".


"Community Water System" means a public water system that serves at least fifteen (15) service connections used by year-round residents. Examples are municipalities and utility districts.

"Non-Community Water System" means a public water system that is not a community water system. This type of water system is further defined as either "Non-Transient", serving the same people each day; and "Transient", which serves a different group of people each day.




Tennessee Public Water Systems

Combined, all of Tennessee public water systems (community, transient and non-transient) serve an estimated population of more than 7,400,000 individuals.




The 10 largest public water systems in Tennessee serve over 2,679,000 people. In contrast, there are 496 water systems, which serve less than 3,300 people each, providing drinking water to an estimated 297,000 people.



Population Categories

Public water systems utilizing ground water sources are the most prevalent in Tennessee. However, surface water is provided to most of Tennessee's population.

- Surface Water (NCWS) = 16,618 people
- Ground Water (CWS) = 1,537,697 people
- Ground Water (NCWS) = 61,579 people

- Ground Influenced by Surface (NCWS) = 2,031 people


Violation Information

Primacy States, such as Tennessee, submit data to the EPA Safe Drinking Water Information System (SDWIS) on a quarterly basis. Data submissions include public water system inventory statistics, the incidence of Maximum Contaminant Level, Major Monitoring, and Treatment Technique violations, and the enforcement actions initiated against violators.


In addition to the quarterly data submittal to the EPA, the 1996 Amendments of the Federal SDWA require States with primacy to prepare and submit an annual report to EPA regarding public water system violations. Further, states with primacy are required to publish and distribute summaries of their reports. After the submittal of the state reports, EPA evaluates and summarizes the reports in an annual national report.

The Annual Compliance Reports, submitted by the Division to both the public and EPA are required to encompass violations pertaining to (1) maximum contaminant levels, (2) treatment requirements, (3) variances and exemptions, and (4) significant monitoring and reporting violations. This report includes those violation types listed above, that occurred during the 2021 calendar year, or were identified prior to calendar year 2021 and remain uncorrected into 2021. It is important to note that the State of Tennessee does not utilize variances and/or exemptions with respect to primary drinking water regulations.

For the calendar year 2021, a total of 367 individual violations met the criteria to be included in this year's report.



Reviewing the violation data in further detail, indicates that the majority of the violations were incurred by Community Water Systems. The ratio of MCL and Treatment Technique violations to Significant Monitoring and Other violations is relatively consistent between both types of water systems.



Appendix A to this report provides a summary compilation of violations regarding each contaminant. Appendix B provides a detailed listing of public water systems with significant monitoring, significant reporting, treatment technique and MCL violations.

Definitions

To aid in the interpretation and understanding of the data included in this year's report, the following definitions are offered:

- Consumer Confidence Report (CCR): By July 1st of each year, every community public water system is required to prepare and distribute a CCR to customers served by the system. The report is required to contain information including the system's source of water, contaminants detected in the water, potential health effects information, mechanisms for customers to influence decisions made by the water system and any violations of drinking water standards that may have occurred during the previous calendar year.
- Ground Water Rule (GWR): Establishes requirements to ensure protection from microbiological pathogens in true ground water sources.
- "Ground water under the direct influence of surface water" means any water beneath the surface of the ground with (1) significant occurrence of insects or other macroorganisms, algae, or other large diameter pathogens such as Giardia lamblia, or (2) significant and relatively rapid shifts in water characteristics such as turbidity, temperature, conductivity, or pH which closely correlate to climatological or surface water conditions. Direct influence must be determined for individual sources.
- Inorganic Contaminants: Non-carbon-based compounds such as metals, nitrates, and asbestos. These contaminants are naturally occurring in some water but can gain access through farming practices, chemical manufacturing, and other human activities.
- Long Term 1 Enhanced Surface Water Treatment Rule (LT1 ESWTR): Establishes criteria that water systems supplied by surface water or ground water under the direct influence of surface water must meet.
- Long Term 2 Enhanced Surface Water Treatment Rule (LT2 ESWTR): Expands on the LT1 rule with microbiological pathogen monitoring at the source, prior to treatment.
- "Maximum Contaminant Level (MCL)" means the maximum permissible level of a contaminant in water which is delivered at the free flowing outlet of the ultimate user of a public water system, except in the case of turbidity and other contaminants so designated where the maximum permissible level is measured at the point of entry into the distribution system. Contaminants added to the water under circumstances controlled by the user, except those resulting from corrosion of piping and plumbing caused by water quality, are excluded from this definition.

- Monitoring Waiver: Permission or consent conveyed to a public water system by the Division of Water Resources upon satisfactory completion of criteria established and necessary to obtain such waiver.
- Organic Contaminants: Carbon based compounds, such as industrial solvents and pesticides. These contaminants generally gain access to water through runoff from cropland or discharge from factories.
- Public Notification Rule: Violations of the Safe Drinking Water Act require public water systems to notify their customers. Violations are categorized by Tier level, and public notice is required to be issued within 24 hours for Tier 1 violations (Acute MCL and certain Treatment Technique violations), within 30 days for Tier 2 violations (Non-Acute MCL and most Treatment Technique violations) and within 1 year for Tier 3 violations (Monitoring, Reporting and Recordkeeping). Failure to issue a Public Notice as required will result in a violation of the Rule.
- Revised Total Coliform rule: Effective on April 1, 2016, revisions to the existing Total Coliform Rule required water systems to revise their bacteriological sampling plans, modified the existing Total MCL to an E.coli MCL, added treatment technique violations, and assessment requirements following certain conditions.
- "Significant Monitoring Violations" are generally defined as a monitoring violation that occurred when no samples were taken, or no results were reported during a compliance period.
- Stage 1 Disinfection/Disinfectant Byproducts Rule (DBP): Establishes requirements to provide protection from microbiological pathogens and limit the amount of disinfection byproducts delivered to the consumer.
- Stage 2 Disinfection/Disinfectant Byproducts Rule (ST 2 DBP): Expands on the Stage 1 rule by requiring a comprehensive distribution system analysis and monitoring at specific locations.
- Surface Water Treatment Rule (SWTR): Establishes criteria under which water systems supplied by surface water or ground water under the direct influence of surface water must provide filtration as a treatment technique.
- Treatment Technique: A water treatment process or procedure that is required instead of a maximum contaminant level for contaminants that laboratories cannot adequately measure.
- Trihalomethanes (THMs) and Haloacetic Acids (HAAs): Disinfection by-products produced as a result of the interaction of a disinfectant (chlorine) with naturally occurring organic material that may be present in the water.

MICROBIOLOGICAL DATA

Microbiological contaminant sampling is conducted by all public water systems in Tennessee to detect biological contaminants that may be present in drinking water. All community public water systems (CWSs) must conduct monitoring on a monthly basis with the number of samples based on the population served. At a minimum, non-community water systems (NCWSs) must monitor each calendar quarter. Non-community systems that serve more than one thousand (1,000) persons, utilize a ground water source under the direct influence (GWUDI) of surface water or utilize surface water in total or in part must monitor on a monthly basis.

The Revised Total Coliform Rule became effective April 1, 2016 and modified several elements of the bacteriological sampling and monitoring requirements. The rule established Treatment Technique violations based on total coliforms and the presence of E.coli, and an MCL for E.coli. Assessments and corrective actions are required based on monitoring results reported, and seasonal Non-Community water systems are required to perform startup procedures prior to opening for the season.

All samples containing total coliforms must be analyzed for the presence of E.coli bacteria. The results of all routine and repeat samples are included in determining compliance with treatment techniques, which may identify the need for corrective actions and assessments. The maximum contaminant level is based on the presence or absence of E.coli in a sample.

If any repeat sample is E.coli-positive, or if any repeat sample is total coliform-positive following an E.coli-positive routine sample, an E.coli MCL violation is incurred. For systems which collect forty (40) or more samples per month, if greater than five (5) percent of samples collected yield total coliform-positive results, the water system is required to perform a Level 1 assessment. Further, for systems collected yields a total coliform-positive the water system is required to perform a Level 1 assessment. For systems that incur an E.coli MCL violation, a Level 2 assessment must be conducted.

Failure by a public water system to perform the required monitoring, corrective action, or assessment constitutes a significant monitoring violation.

During the calendar year 2021, no water system incurred MCL or Treatment Technique violations under the Total Coliform Rules. Appendix B provides detail information for significant monitoring violations of the Total Coliform Rules.

SURFACE WATER TREATMENT RULES

The Enhanced Surface Water Treatment Rule (ESWTR), the Long Term 1 Enhanced Surface Water Treatment Rule (LT1 ESWTR) and the Long Term 2 Surface Water Treatment Rule (LT2SWTR) utilizes and establishes treatment techniques in lieu of maximum contaminant levels for Giardia lamblia, cryptosporidium, viruses, heterotrophic plate count bacteria, Legionella, and turbidity. Treatment techniques are water treatment processes employed for the treatment and/or removal of contaminants in lieu of establishing a Maximum Contaminant Level for contaminants that are very difficult to measure. In accordance with such requirements, water systems supplied by surface water or ground water sources under the direct influence of surface water must utilize water treatment processes (filtration and disinfection) that will achieve removal of cryptosporidium and/or inactivation of Giardia lamblia cysts and viruses. Water systems must perform analyses of the water in order to ensure the proper operation and effectiveness of the filtration and disinfection treatment.

In accordance with the Enhanced Surface Water and Long Term 1 Enhanced Surface Water Treatment Rules, water systems must monitor the water for turbidity (cloudiness of the water) and disinfectant residual. If a water system fails to conduct required monitoring or fails to monitor and report less than ninety (90) percent of the required samples, as determined by population served and duration of water plant operation, then a significant monitoring violation is incurred. If a water system conducts required monitoring and reporting and the results reveal that less than ninety-five (95) percent of samples collected met the turbidity standard or disinfectant residual standard, then a treatment technique violation is incurred. Additionally, if a water system utilizing surface water or ground water under the direct influence of surface water fails to meet all criteria to avoid filtration treatment and does not install the necessary filtration treatment within the allowable eighteen (18) month deadline, then a violation is incurred regarding the failure to filter requirement.

The goal of the Long Term 2, Surface Water Treatment Rule is to reduce the risk of disease caused by Cryptosporidium and other microorganisms by identifying those systems at the greatest risk for source water contamination. Under this rule, most filtered systems were required to conduct an initial round of sampling of their untreated source water for the presence of Cryptosporidium and/or E.coli bacteria. Results from this initial round were used to determine if additional treatment of the source water was required. The second round of source water monitoring is complete for most public water systems in Tennessee.

Treatment technique and significant monitoring violations pertaining to any of the applicable Surface Water Treatment Rules are included in the detailed listing of violations provided in Appendix B.

INORGANIC CONTAMINANTS VIOLATIONS

Inorganic contaminant sampling is conducted by all public water systems in Tennessee to detect inorganic contaminants such as metals, nitrates or asbestos that may be present in the drinking water. Maximum contaminant levels have been established for inorganic contaminants and monitoring determines compliance with such standards. Monitoring intervals for inorganic contaminants are determined considering the type of source water utilized by the public water system with the exceptions of nitrate and asbestos. Monitoring to determine compliance with the maximum contaminant level for nitrate may be conducted no less frequently than annually. Monitoring to determine compliance with the maximum contaminant level for asbestos is conducted with consideration to population served and the vulnerability of the system to asbestos contamination (asbestos-cement piping, etc.).

During the calendar year 2021, there were no public water systems that incurred a maximum contaminant level violation regarding inorganic contaminants. Significant monitoring violations pertaining to any of the inorganic contaminants are included in the detailed listing of violations provided in Appendix B.

ORGANIC CONTAMINANTS VIOLATIONS

Organic contaminant sampling is conducted by all community and certain noncommunity public water systems in Tennessee, which have not received a waiver of the monitoring requirements, to detect any organic contaminants such as solvents or pesticides which may be present in the drinking water. Maximum contaminant levels have been established for organic contaminants and monitoring determines compliance with such standards. Monitoring intervals for organic contaminants are determined considering the type of source water utilized and the type of population served by the public water system. Water systems that conduct monitoring for organic contaminants and do not detect a contaminant may reduce the sampling frequency regarding organic contaminants or request permission from the State to reduce sampling frequency.

During the calendar year 2021, there were no public water systems that incurred a maximum contaminant level violation regarding organic contaminants. Significant monitoring violations pertaining to any of the organic contaminants are included in the detailed listing of violations provided in Appendix B.

DISINFECTION BY-PRODUCT and BY-Product PRECURSOR VIOLATIONS

Trihalomethane (THM) and haloacetic acid (HAA5) sampling is conducted by all community public water systems in Tennessee. Trihalomethanes and haloacetic acids are disinfection by-products that are produced as the disinfectant (chlorine) reacts with naturally occurring organic matter, such as leaf litter, which may be present in the water. Monitoring is conducted to detect the presence of trihalomethanes or haloacetic acids in the drinking water. A maximum contaminant level has been established for both total trihalomethanes and total haloacetic acids and monitoring determines compliance with the standards. Monitoring is conducted for both TTHMs and HAA5 generally on a quarterly basis and on each water treatment plant used by a system. Other monitoring schedules may be followed depending on the size of the system and the type of source water.

The standard or maximum contaminant level for TTHMs is 80 parts per billion (ppb) while the standard for HAA5 is 60 ppb. Compliance with MCLs is determined at each sampling location individually and is calculated as a running annual average of the results reported for the current and prior 3 quarters.

MCL and significant monitoring violations pertaining to disinfectants, disinfection byproducts and disinfection by-product precursors are included in the detailed listing of violations provided in Appendix B.

LEAD AND COPPER VIOLATIONS

Lead and Copper sampling is conducted by all community and certain non-community public water systems in Tennessee at high risk sites to detect excessive levels of lead and/or copper in drinking water. The maximum allowable concentrations of lead and/or copper in drinking water are denoted as "action levels". Treatment techniques have been established that include requirements for corrosion control treatment, source water treatment, lead service line replacement and public education for systems which exceed the action levels for lead and/or copper. Tap water monitoring determines compliance with such standards. The results for each location are required to be presented to the property owner within 30 days of receipt. Initial tap water monitoring is conducted for lead and copper on six (6) month monitoring intervals. If a water system meets the action levels for lead and copper during each of two (2) consecutive six (6) month monitoring periods, or maintains optimal corrosion control, the system may request and be granted reduced monitoring frequencies.

Violations for failure to monitor under the Lead and Copper Rule during the calendar year 2021, are included in the detailed listing of violations provided in Appendix B.

CONSUMER CONFIDENCE REPORT VIOLATIONS

Beginning in 1998, community public water systems were required to furnish a report to customers with information about the water being furnished. Included in this report is the source of water for the local water utility, certain health effects language, information concerning contaminants detected, and information on violations that may have occurred during the previous calendar year. There is also information on the time and location of any board meetings to promote public participation in the decision-making process of the water utility.

All systems serving 10,000 or more persons are required to furnish a copy of the report to each customer and the Division of Water Resource by July 1 each year. Systems serving less than 10,000 persons are given the option to notify their customers that the report will be published in a newspaper serving the local area. Even though the report is published in the paper, the water utility is required to furnish an individual copy of the report to any person requesting a copy.

During the calendar year 2021, there were 73 public water systems that incurred a significant reporting violation under the Consumer Confidence Report rule.

RADIONUCLIDE VIOLATIONS

Public water systems are required to monitor for certain naturally occurring and manmade radionuclides to ensure the water being provided to their customers meet standards. Radionuclide samples are collected every quarter with the results being the average of all the quarterly samples.

During the calendar year 2021, no public water systems incurred significant monitoring or MCL violation for Radionuclide parameters.

GROUND WATER RULE

The Ground Water Rule is part of the "Microbial-Disinfectants/Disinfection Byproducts Cluster" (M-DBP Cluster), intended to improve control of microbial pathogens while minimizing public health risks of disinfectants and disinfection byproducts (DBPs). The GWR builds upon the Total Coliform Rule by addressing the health risks of fecal contamination in community and non-community water systems that use ground water. Key provisions of the rule include; compliance monitoring to ensure that treatment technologies installed to treat drinking water reliably achieves at least 99.99 percent (4-log) inactivation or removal of viruses; triggered source water monitoring to test for the presence of fecal indicators; and, requirements to correct significant deficiencies and eliminate fecal contamination through specified actions.

During the calendar year 2021, three (3) water systems incurred treatment technique violations, and five (5) water systems incurred significant monitoring violations under the GWR.

DIVISION OF WATER RESOURCES ENFORCEMENT ACTION SUMMARY

The Department of Environment and Conservation and the Division of Water Resources are both granted authority by the Tennessee Safe Drinking Water Act, to initiate enforcement action and issue administrative orders regarding violations of the Tennessee Safe Drinking Water Act.

In order to address non-compliance issues the Division of Water Resources utilizes a number of enforcement mechanisms which include: Compliance Status Notifications, Notices of Violation (NOVs) and/or Notices of Non- Compliance (NONCs); technical assistance and training; Compliance Review (CRM) and/or Show Cause meetings (SCM); and issuance of administrative orders and assessments which contain monetary civil penalties.

The Division initially attempts to assist water systems with violations achieve compliance through a system of official notifications, technical assistance and training, on-site inspections, and compliance review meetings. Under certain circumstances, water systems are provided the opportunity to execute a Letter of Agreement (LOA) indicating an understanding of noncompliance issues and conveying an agreement to undertake the necessary actions to prevent a recurrence of non-compliance. In situations where the division has issued notifications, conducted technical assistance and/or on-site inspections or conducted compliance assessment meetings and violations are not addressed by the water utility or are not addressed in a timely manner, enforcement action in the form of an Administrative Order (AO) is customarily recommended and/or initiated. Such Administrative Orders contain monetary civil penalties assessed for violations and mandate that compliance be achieved.

Most violations incurred by water utilities are addressed and corrected prior to the necessity for issuance of an Administrative Order. With technical assistance and training provided by the division, most water systems can return to compliance. However, there are water systems that incurred violations that were not adequately addressed or corrected making an Administrative Order warranted. The Administrative Orders encompassed a variety of violations including those contained in this Annual Report of Violations.
