

The purpose of this notice is to advise the public of the following proposed permit action and solicit comments and information necessary to evaluate the potential impact of the proposed activities on the aquatic environment.

Pursuant to The Tennessee Water Quality Control Act of 1977, T.C.A. §69-3-108 and Tennessee Rules, Chapter 0400-40-07, the proposed activity described below has been submitted for approval under an Aquatic Resource Alteration Permit and Section 401 Water Quality Certification. Section 401 of the Clean Water Act requires that an applicant obtain a water quality certification from the state when a federal permit is required. This notice is intended to inform interested parties of this permit application and draft permit and rationale, and to ask for comments and information necessary to determine possible impacts to water quality. At the conclusion of the public notice period a final determination will be made whether to issue or deny the permit.

PROJECT DESCRIPTION / PURPOSE

Black Rifle Coffee Company (BRCC) is planning a building expansion project of 60,000 square feet. The expansion will require impacts to wetlands and streams located on the property. As part of the construction project, an existing 60- foot stream crossing on Stream 2 will be replaced with a 96- foot stream crossing. No compensatory mitigation will be required.

The wetland identified in the delineation as WTL-1, which consists of a 4.52-acre wetland. The building expansions will require that 1.47 acres of wetland be impacted for the completion of the project. An additional acreage of 0.01 acres of wetland previously permitted for a roadway crossing will also be included in the mitigation plan, for a total of 1.48 acres of impact. Of the 1.48 acres of impact, 1.29 acres will consist of permanent impact and 0.19 acres will consist of conversion to detention basin but will be maintained as a wetland.

Onsite Wetland Credits:

Wetland Preservation – Land restrictions will be established for the portions of WTL-1 that are not to be disturbed, labeled as Preservation Area in the Mitigation Plan. This area consists of 3.04 acres. At a 10:1 mitigation ratio, the wetland preservation will mitigate for 0.30 acres of wetland impact.

Offsite Wetland Credits:

1.48 acres of wetland impact -0.30 acres of onsite wetland mitigation = 1.18 acres

1.18 acres x 2:1 ratio will require 2.36 offsite credits.

Due to the distance to the Sequatchie Valley mitigation bank, a proximity factor of 1.5 will be applied. Upon application of the proximity factor, the 2.36 credits become 3.54 offsite credits.

ANTIDEGRADATION STATEMENT

For compensatory mitigation onsite: In accordance with the Tennessee Antidegradation Statement (Rule 0400-40-03-.06), the Division has made a preliminary determination that the proposed activities will result in de minimis degradation to 0.3 acres of impact because the applicant proposes to provide in-system mitigation with the preservation of 3.04 acres to offset any appreciable permanent loss of resource values.

In accordance with the Tennessee Antidegradation Statement (Rule 0400-40-03-.06), the Division has made a preliminary determination that the proposed activities will result in greater than de minimis degradation of 1.18 acres of impact of waters with available parameters to be compensated for at the Sequatchie Wetland Mitigation Bank. Any appreciable permanent loss of resource value associated with the proposed impact is proposed to be offset by sufficient mitigation to result in no overall net loss of resource value. Pursuant to Antidegradation Statement, in waters with available parameters for habitat, an activity that would cause degradation of habitat above the level of de minimis will only be authorized if applicant has demonstrated to the Department that there are no practicable alternatives to prevent or lessen degradation associated with the proposed activity and the degradation is necessary to accommodate important economic or social development in the area and will not violate the water quality criteria for uses existing in the receiving waters.

FACTORS CONSIDERED

In deciding whether to issue or deny this permit, the Division will consider all comments of record and the requirements of applicable federal and state laws. The division will consider the nature, scale and effects of proposed impacts. The Division will consider practicable alternatives to the alteration, loss of waters or habitat, diminishment in biological diversity, cumulative or secondary impacts to the water resource, and adverse impacts to unique, high quality, or impaired waters.

In making this decision, a final determination will be made evaluating appreciable permanent loss of resource values and proposed compensatory mitigation to ensure the project will not result in no overall net loss of state water resources values.

HOW TO COMMENT

TDEC is requesting public comment on this proposed permit action. Obtaining a broad range of facts and opinions on Agency actions is one of the best ways to ensure appropriate decisions. Persons wishing to comment on the proposal are invited to submit written comments to the Division. Written comments must be received within **thirty days following distribution of the approved public notice materials** (including signage and newspaper ad). Comments will become part of the record and will be considered in the final decision. The applicant's name and permit number should be referenced. After the Division makes a final permit determination, a permit appeal may be filed by the applicant or by any person who participated in the public comment period whose appeal is based on comments given to the Division in writing during the public comment period or in testimony at a formal public hearing. When there is sufficient public interest in water quality issues, the Division will hold a public hearing in accordance with 0400-40-07-.04(4) (f). Any scheduled public hearings will be advertised through a similar public notice process.
