#### What is a cooperative contact?

Cooperative purchasing involves two or more government entities procuring items from the same contract. Usually there is a lead state that develops the cooperative concept and releases a solicitation. After the lead state awards the contract(s) to one or more suppliers, each individual state has to develop their own participating addendum (PA) in order to "piggyback" off of the lead state's contract. These PA's are developed between the individual state and the supplier(s) chosen from the awarded supplier(s) list established by the lead state.



### Who Can Use Cooperative Contracts?

Authorized Users may utilize statewide contracts by purchasing directly from the awarded Contractor(s) in accordance with their own procurement policies and procedures.

#### SWC# 440 Medical Supplies and Equipment Contract Information and Usage Instructions

**Contract Period:** This is a cooperative statewide contract established through the Minnesota Multistate Contracting Alliance for Pharmacy (MMCAP). To date, the State has signed one (1) participating addendum with McKesson for an initial start date of February 25<sup>th</sup>, 2019. The contract's initial end date is March 1st, 2020 but it may be extended for up to three (3) additional one (1) year periods upon execution of a written amendment and acceptance of both parties, for a total term not to exceed five (5) years.

### Participation in Other ValuePoint Contracts

- Higher Education and Local Governments in Tennessee may enter participating addendums to utilize NASPO ValuePoint master agreements if doing so is permissible under their own statutory authority and procurement procedures. Any agreements are subject to the approval of the particular entity involved.
- In general, under Tenn. Code Ann. § <u>12-3-101</u> all goods and services for the use of state government, shall be purchased and contracted for by the Central Procurement Office unless a particular exemption applies. There are several state governmental entities and types of contracts that are exempt. For a list of exemptions, please see Tenn. Code Ann. § <u>12-3-102</u>.
- The Central Procurement Office may participate in cooperative purchasing agreements, including NASPO ValuePoint contracts, under Tenn. Code Ann. § <u>12-3-512</u>.
- Many exempt governmental entities have their own statutory authority to enter into a cooperative purchasing agreement that is awarded through full and open competition.
  - For details regarding some of the cooperative purchasing requirements for a public institution of higher education please see Tenn. Code Ann. § <u>12-3-512</u>.
  - For details regarding some of the cooperative purchasing requirements of a municipality, county, utility district, or other local government of the state please see Tenn. Code Ann. § <u>12-3-1205</u>.
