Has TN collected data on how much the award-winning program has yielded results superior for Michigan to traditional procurement methods, as it applies to IT contracts that include hardware, software & services – for modernization and Maintenance & Operations?	The State has not collected specific data regarding results.
2	Section 1, Page 1: "a new procurement method for the state to utilize called the Competitive Proof of Concept program."	For IT Services initiatives, Agile principles & methodologies are being adopted across industries and have been found to be effective. Most of the benefits and costs associated with CPC (Competitive Proof of Concept) can be achieved by utilizing Agile principles. To that end, has the State given thought to building in mandatory requirements for Agile methods (Scrums, 2-week sprints, Retrospectives) on IT projects while adopting traditional RFP procurement methods?	Yes. The State has implemented or required Agile principles or methodologies on some previous IT solicitations and projects.
3	Section 2, Page 5: Award multiple, optional-use contracts, or award by Contract Activity	Should the State award multiple contracts, would allocating limited IT staff across multiple POC projects simultaneously be a challenge? Has the State undergone such a scenario building exercise? If yes,	Yes, this could be a challenge the State would have to carefully navigate. The State has not undergone this scenario building exercise.
