Legislation

There is no new legislation affecting the Council at this time.

Rule Activity

Changes to Rules 1370-02-.01, .04, .05, .06, .08, .09, and .14 regarding definitions, preliminary qualifications for licensure, procedures for licensure, fees, apprentice examinations, renewal of license, and apprentice training programs are currently in the internal review process. Ms. Lanford advised that the process is moving so that we may be able to have a rulemaking hearing at the next Council meeting, on May 12, 2017.

Disciplinary Activity

The Office of General Counsel currently has <u>two</u> (2) open cases. There are no cases to present to the Council today, nor any that have been appealed to the Chancery Court.

Investigative Report

Nichelle Dorroh, from the Office of Investigations advised the Council that there are currently **eleven** (11) cases open, and the Investigations department is currently monitoring **four** (4) disciplined practitioners.

Financial Report

Butch Jack, representing the Fiscal department, presented the financial report for Year End 2016.

Administrative Report

Mr. Custer presented the Administrator's report to the Council, which also included a report on the current status of the Council Operations Fee. Mr. Custer advised that there are currently a total of 145 licensed practitioners, and 28 licensed apprentices.

Mr. Custer also presented a report on the progress of the exams.

Mr. Custer advised the Council that the Tennessee Hearing Society annual meeting in Pigeon Forge is scheduled for the weekend of May 20, 2017. Mr. Custer stated that in past years, the Council has voted to send members of the administrative staff to the conference to assist in answering questions. Dr. Rayne made a motion, seconded by Ms. Smith, to send administrative staff to the conference. The motion carried.
