Dr. Rivard called the meeting to order at 9:20 a.m. A roll call voted was conducted and a quorum was present.

Dr. Rivard asked that a plaque be made in recognition of Dr. Longs eight years of service to the Board.

Minutes

Upon review of the August 19, 2015 minutes, Dr. Sables made a motion, seconded by Ms. Oglesby, to approve the minutes as written. The motion carried.

Office of General Counsel

Ms. Huddleston stated there is one (1) open case in OGC and will be presented at this meeting as an Agreed Orders.

Ms. Huddleston stated that there is pending legislation SB1723, HB 1906 which authorizes a licensed podiatrist to supervise a physician assistant; requires a supervising podiatrist and physician assistant to comply with certain statutory requirements and administrative rules; prohibits a physician assistant supervised by a podiatrist from providing certain services; subjects

a podiatrist to disciplinary action for failing to supervise properly a physician assistant. The Board took no position at this time.

Ms. Huddleston presented an Agreed Order regarding Christopher Alexander, Prosthetist. Mr. Johnson was arrested on or about July 5, 2015 for possession of a pipe bomb and suspected in the bombing of Victory Orthotics & Prosthetics. Mr. Alexander was indicted in the United States District Court, Eastern District of Eastern Tennessee, at Greenville on or about July 14, 2015. Mr. Alexander was indicted under one count of damaging a building and property, use in commerce, by means of fire and explosives and three counts of knowingly possessing of a firearm, that is, a pipe bomb, not registered to you in the National Registration and Transfer Record. Mr. Alexander voluntarily surrendered his prosthetist license, license number 75 and must pay actual and reasonable costs associated with the investigation and prosecution of the case. The maximum assessment of costs shall be limited to One Thousand Dollars (\$1000.00). Mr. Fillauer made a motion, seconded by Ms. Oglesby to accept the agreed order. The motion carried.

Ms. Huddleston presented to the Board the revised policy on lapsed license. Dr. Schuler made a motion, seconded by Mr. Fillauer to approve the revised policy with changes. Dr. Sables opposed. The motion carried.

Ms. Huddleston said the Lawrence case is still on appeal and waiting a decision by the Chancellor of Chancery Court.

Financial Report

Ms. Vanessa Crutcher presented the financial report for yearend closing for 2015. Total direct expenditures \$ 12,596.27, Allocated expenditures \$21,488.97, with total expenditures of \$ 58,618.17, Total revenue \$103,627.75 current year net \$ 45,009.58 with a carryover of \$243,759.16.

Ms. Crutcher reviewed the policy regarding the large amount of carryover the Board has and suggested that if the carryover keeps growing the Board may wish to have a discussion of reducing fees.

Office of Investigations

Nichelle Dorroh stated there is currently one (1) open complaint in investigations against a Podiatrist.

Ms. Dorroh reviewed the currently monitored practitioners report with the Board.

Dr. Rivard asked that the Board have a selection of three to serve as consultant for review investigative cases to include at least one from the profession of Orthotics, Prosthetics, and Pedorthotists.

The Board welcomed Ms. Antoinette Welch, Director of investigations.

Applicant Interview

The Board reviewed the file of **Michelle Kirkland** for Podiatric X-Ray Operator. Mr. Fillauer made a motion, seconded by Dr. Schuler to approve the file for Certification. The motion carried.

Administrative Report

Mr. Hill stated as of January 2016 there are currently two hundred sixty three (263) actively licensed Podiatrists; one hundred twenty nine (129) Podiatric X-ray Operators; one hundred forty nine (149) Orthotists; one hundred forty five (145) Prosthetists; and, fifty five (57) Pedorthists.
