Ms. Harmon, board chair, called the meeting to order at 10:06 a.m. A quorum was present. The Board decided to delay the contested case hearing, to allow for the judge's arrival.

Minutes

Dr. Mauldin made a motion, seconded by Dr. Matlock, to approve the June 3, 2013 minutes as presented. The motion carried.

OGC Report

There is one (1) open case in OGC, against a Speech Pathologist, a contested case to be presented to the CDS Board and there are no cases that have been appealed to the Chancery Court. There are no consent orders or agreed orders to be presented.

The rules regarding tele-communication that were approved by the Board at the last meeting are awaiting approval at the Attorney General's office.

The rules approved by the Board at last November's rule making hearing are still awaiting approval from Government Operations Committee at the end of August.

There is currently no legislation to report, as the General Assembly is not is session.

Mr. Munderloh presented a draft of language for the proposed rule change regarding new requirements for supervising Speech Language Pathologists who are supervising Clinical Fellows and Speech Language Pathology Assistants. Ms. Flynn made a motion, seconded by Dr. Mauldin, to approve the draft language as presented, and send to a rule making hearing at the next Board meeting. The motion carried.

John Williams, from TAASLP, presented information to Mr. Munderloh and the Board that the Tennessee Hearing Society is considering proposing legislation to request the separation of the Council for Hearing Instrument Specialists from the Board of Communication Disorders and Sciences. Mr. Williams advising that there is nothing pending at this moment, but requested the topic be placed on the agenda for the next Board meeting for open discussion.

Review Continuing Education

The Board reviewed information for **Ava Adcock, SLP**. Ms. Adcock was selected in the continuing education audit, and had submitted information that the Board administrator had questions about. The concerns were presented that Ms. Adcock has practiced for nearly 30 years without any disciplinary action against her license. Ms. Adcock was present to address the Board and answer questions, and stated the she was planning to retire from the profession at the end of the current school year; additionally, as the school system would be left without a speech pathologist, she does not want to retire her license at the present time. The Board gave Ms. Adcock the option to either retire her license early or be issued an agreed citation due to a deficiency of two (2) hours of continuing education. Dr. Matlock made a motion, seconded by Dr. Mauldin, to approve the presented CE. The motion carried.

Contested Case Hearing

A contested case hearing was conducted against **Lisa G. Patterson, SLP**, **Docket #17.16-120572A**, for failure to adhere to a previous Board order to report for evaluation of substance abuse issues. Judge Mary Collier presided. The hearing commenced at 10:41. After hearing preliminary evidence and testimony regarding the multiple service attempts to advise Ms. Patterson of this hearing, Ms. Flynn made a motion, seconded by Dr. Matlock, to grant the motion to hold the defendant in default. The motion carried. Judge Collier advised that this hearing shall proceed as uncontested. After hearing testimony and evidence regarding the charges brought forth by the Board attorney, the Board voted to approve the proposed final order as presented. Judge Collier advised Mr. Munderloh that the final order would need to be amended only by changing the name of the presiding judge on the first page of the order. The hearing concluded at 11:39.

Investigative Report

There are four (4) open complaints against speech pathologists. There are two (2) open complaints against an audiologist. There are no open complaints for Speech Language Pathology Assistants.

Monitored Practitioners

Investigations are currently monitoring four (4) practitioners on probation, and one (1) Board Order.

Administrative Report

As of July 31, 2013, there are 367 licensed audiologists, 2175 licensed speech pathologists and 90 registered speech language pathology assistants. Between April 25, 2013 and July 31, 2013, 39 Audiologists have renewed their licenses. Out of the 39, 19 renewed online, giving a 48.7% renewal rate. For the same time period 241 Speech Pathologists have renewed their licenses. Out of the 241, 121 renewed online giving a 50.2% renewal rate.

The Board was advised of a change in the current Lapsed License Policy. The change is that as of now, any licensee practicing after their license has expired is now reported to the National Practitioner Databank, in addition to the State of Tennessee databank.

The new Conflict of Interest Policy was presented. The Board members were advised of some changes within the policy, specifically the clause pertaining to payment for activities relating to official duties, except as already approved by the Department of Finance and Administration. The example was given of a society paying for travel and lodging to a conference. The members were advised that each of them had a new copy to sign and return to the Administrator.

The Board discussed a plan of action regarding Public Chapter 122, formerly known as SB 0493, regarding military spouse licensing. Ms. Wilkins advised the Board that work is progressing on the legislative side to implement this action.

Mr. Custer also presented to the Board a proposed letter to state universities advising the Board's rules regarding licensed supervision of clinical students. The Board approved the letter with some minor changes, to be sent as soon as possible.

Mr. Custer presented to the Board a proposed letter of audit for Speech Language Pathology Assistants. The Board approved the letter with some minor changes being made. The Board advised that the letter should be sent after the new rules become effective, on September 26, 2013, and should also be sent with a copy of the current rules at that time.
