Ms. Wilkins introduced the new board members, Dr. David Haynes from Vanderbilt replaced Dr. Kimberly Vinson, and Ms. Alicia Barker, Audiologist, replaced Velvet Buehler.

Due to lack of a chair, Ms. Wilkins called the meeting to order at 10:03 am. A roll call was conducted and a quorum was present.

Review/Approve Board Meeting Minutes

Upon review of the October 29, 2019 minutes, Mr. Morton made a motion, seconded by Ms. Mills, to approve the minutes as written. A roll call vote was held and all voted in the affirmative. The motion carried.

Investigative Report

Ms. Lori Leonard, Disciplinary Coordinator for all non-nursing Boards gave the following report:

Summary of Currently Monitored Practitioners

There are three (3) currently monitored practitioners; one (1) under a Board Order who has been sent to collection for the balance of the Civil Penalties., One (1) under Probation until 2020, and one under Revocation who is making payments on her fee's

Board Statistical Complaint Report

SLP's: There were six (6) new complaints for 2019; two (2) were for falsification of records, one (1) for fraud and false billing and two (2) regarding a lapsed license. A total of five (5) complaints were closed; one (1) closed with insufficient evidence, one (1) closed and sent to the Office of General Council for formal discipline, and two (2) closed with letters of warning. Currently there are five (5) open complaints being investigated and/or reviewed.

Audiologist: There were two (2) new complaints in 2019; one (1) for criminal charges, and one (1) for malpractice and negligence. No closed complaint and there are currently eight (8) open complaints being investigated and/or reviewed at this time.

SLP-A's: No new complaints in 2019, no closed complaints and none opened to be investigated.

OGC Report

Ashley Fine presented the following OGC report; Ms. Fine read aloud the Conflict of Interest Policy and Open Meeting Act Policy.

Disciplinary Activity

At this time there one (1) open case in the Office of General Counsel which will be settled with a Consent Order to be presented today.

The Clinical Fellow Provisional License rules are still in internal review.

Consent Order

Ms. Fine presented a Consent Order for **Elena P. Brown**, SLP license number 5997. Ms. Brown's license expired and she failed to renew in a timely fashion. She worked on a lapsed license for approximately seven (7) months. Ms. Brown must pay a civil penalty in the amount of Six Hundred Dollars (\$600.00) representing a penalty in the amount of One Hundred Dollars (\$100.00) for each month she practiced on a lapsed license after the thirty day (30) day grace period expired. Ms. Brown must also pay reasonable costs incurred for the prosecution of the case.

A motion to accept the Consent Order as written was made by Mr. Morton and seconded by Ms. Mills. All voted in favor of accepting the Consent Order. The motion carried.

Administrative Report

Ms. Tamayo provided the following administrative report:

As of February 7, 2020, there are a total of 466 licensed Audiologists, 3019 licensed Speech Language Pathologists and 139 registered Speech Language Pathology Assistants.

Between, October 23, 2019 and February 7, 2020:

There were seven (7) newly licensed Audiologists, two (2) new audiology Clinical Externs, one (1) retired, two (2) expired, and three (3) reinstatements. A total of seventy-nine (79) Audiologists renewed with sixty-three (63) of the total renewing online which is a percentage of eighty (80%).

There were fifty-three (53) newly licensed Speech Language Pathologists, seventeen (17) new Clinical Fellows, six (6) retired; thirty (30) expired and ten (10) reinstatements. Three hundred forty-seven (347) Speech Pathologists have renewed their licenses with two hundred seventy-nine (279) renewing online for a percentage of eighty (80%).

There were five (5) newly registered Speech Language Pathology Assistants, two (2) retired, two (2) expired, and zero (0) reinstatements. A total of four (4) Speech Language Pathology Assistants renewed their licenses with two (2) renewals completed online for a percentage of 50%.

Correspondence

A letter was received from Angela Tidquist, AuD, requesting a waiver of her continuing education hours for 2019. She is requesting a waiver due to being pregnant during most of 2019. She stated

By roll call vote, the board voted to take no action on Dr. Tidquest's request for a waiver of her 2019 continuing hours.

A letter was received from Ms. Susan Usery, Speech-Language and Related Services Coordinator, Division of Special Population and Student Support. Ms. Usery related the qualifications for a Speech Language Pathology Assistant required by the Department of Education, one of these being a bachelor's degree. The board does not require this degree for a registration as a Speech Language Pathology assistant degree. Ms. Fine passed out a copy of the board's draft rules which speak to this issue. Ms. Wilkins also had passed out minutes from the August 2018 meeting in order that the board might read the prior board's discussion of Speech Language Pathology Assistants supervision. Ms. Usery stated her department wants clarification on the board's requirements for supervision of a Speech Language Pathology Assistant and whether or not they align with the Department of Education's guidelines. After much discussion of this topic, Mr. Morton moved to take no action, seconded by Ms. Mills. A roll call vote was held and all voted in the affirmative. The motion carried.

Election of Officers

Ms. Crittendon nominated Ms. Starr for board Chair seconded by Mr. Morton. A roll call vote was held and all voted in the affirmative. The motion carried.

Adjournment

With no other Board business to conduct, Mr. Morton made a motion, seconded by Ms. Starr to adjourn the meeting. The motion carried, the meeting was adjourned at 11:05 a.m.
