Ms. Phipps, Chair called the meeting to order at 9:07 a.m. A roll call vote was conducted and all Board members were present.

Ms. Wilkins asked staff to introduce themselves: Teddy Wilkins, Unit Director; Latonya Shelton, ASA3 and Caroline Tippens, Assistant General Counsel.

Minutes

Upon review of the July 14, 2017 minutes Mr. McNeil made a motion, seconded by Mr. Brown, to approve the minutes as written. The motion carried.

Office of General Counsel (OGC)

Ms. Tippens stated there are no cases against Licensed Alcohol and Drug Abuse Counselors in OGC.

Ms. Tippens stated the proposed rules pertaining to deletion of the word "behavioral health" and continuing education changes is internal review. Our Chief Deputy for the Office of General Counsel is currently reviewing. Next, the rules will go onto the Commissioner's Office and

Governor's office for review. Ms. Tippens informed the Board there are no cases pertaining to licensed alcohol and drug abuse counselors currently in the Office of General Counsel.

Office of Investigations

Ms. Leonard stated her office is currently monitoring two (2) practitioners; there are three (3) open complaints and four (4) closed.

Administrative Report

Ms. Shelton stated there are 438 licensees; four (4) level one applications; three (3) level two applications; and three (3) reinstatement applications.

Ms. Shelton stated fourteen (14) licenses have been issued; six (6) retired; twelve (12) expired; and, fifty-four (54) renewals. Ms. Shelton said thirty (30) licensees renewed on-line for a total of fifty-six percent (56%).

Ms. Shelton stated the next meeting is January 6, 2018.

Financial Report

Ms. Noranda French reviewed the Financial Report stating for fiscal year ending June 30, 2017 actual revenue and expenditures. The Board had direct expenditures of \$52,305.38 and allocated expenditures of \$11,926.17 for total expenditures of \$64,231.55. Ms. French said Board Fee Revenue totaled \$74,207.00, current year net \$9,975.45 and LARS improvements of \$2950.63 for a total cumulative carryover of \$109,884.72.

It was discovered that this class was given prior to the Boards approval process. For future continuing education and training hours to be approved this course will have to be resubmitted for approval according to rule 1200-30-01-11(3) -Continuing education program approval process for providers of education. Mr. Brown made a motion, seconded by Mr. McNeil, to approve Mr. Callihan as a continuing education provider. The motion carried.

With no other business to conduct, the meeting was adjourned at 10:57 a.m.
