**EMS REPORT**

At the September 12, 2012 Board for Licensing Health Care Facilities meeting, Holston Valley Medical Center, Kingsport, and Erlanger Medical Center, Chattanooga, were presented for redesignation approval as Level I trauma centers. Holston Valley Medical Center underwent a site visit in 2010 with deficiencies identified. As a result of the 2010 site visit the facility presented their plan of correction to the Board for Licensing Health Care Facilities at the September 14, 2011 meeting which was followed by a focus site visit. As a result of the September 2011 Board for Licensing Health Care Facilities' meeting Holston Valley Medical Center was granted a provisional designation as a Level I trauma center. The Board lifted the provisional designation and approved a redesignation of the facility as a Level I trauma center. The Board also approved Erlanger Medical Center for redesignation as a Level I trauma center.

At the February 7, 2013 Board for Licensing Health Care Facilities' meeting, The Regional Medical Center at Memphis, Memphis, and Vanderbilt University Medical Center, Nashville, were presented for redesignation approval as Level I trauma centers. Also, presented was the Legislative Report on Trauma.
