#### Discuss, Review, And Take Action, if Needed:

Discuss lab surveyor workload.

Ms. Sarah Harvey, Director of Health Care Facilities, presented information to the Board regarding the upcoming merger between Health Care Facilities (HCF) and Health Services and Development Agency (HSDA) to form the Health Facilities Commission (HFC). An interagency agreement will be in place at the next Board meeting regarding the use of lab surveyors. HCF will present a proposal to the Board regarding their suggestions for addressing the survey backlog. After

discussion, the Board indicated they wanted a report each Board meeting from the CLIA Manager regarding the lab surveyor workload and backlog. The Board also requested a crosswalk from the CLIA Manager that listed the laboratories that did not have any surveyor visit from both CLIA and State licensure.

The option of performing remote self-audit state licensure surveys was discussed. The Board decided to table the final decision on remote surveys pending a legal interpretation.

The facility is using the waived Sysmex XW-100 instrument. After discussion, the Board decided the facility only needed to submit a Waived Testing Notification form for the waived tests.

CMS asked if the Medical Laboratory Board would consider adding additional educational information to the personnel license so it could serve as a primary source verification (PSV) document for CMS.

Dr. Vincent LaRussa with the University of Tennessee Medical Center in Knoxville requested clarification from the Board if their Cell Therapy Laboratory would need to obtain a state license. After discussion, the Board decided that even though the lab is using the results to produce a product, the results are also being used for patient healthcare decisions because they are included in the patient's lab report. Based on this information, the lab does need to be state-licensed.
