Ms. England presented a document for board review concerning the necessity of continuing the renewal of a facility that currently possesses a Tennessee laboratory license if anatomic/clinical laboratory testing procedures were not currently performed in that physical location.

All licenses granted by the board are with the intent of full compliance with statute Tennessee Code Annotated §68-29-101, and the rules and regulations promulgated by the board for medical laboratory operations.

However circumstances may arise which can produce a delay in the services and analyses of specimens, especially in the newer area of emerging technologies relative to the actual processing of clinical samples for prognosis, diagnosis or treatment of an individual.

After discussion board members decided it was the holder of the laboratory license who makes the business decision of whether to voluntarily relinquish the license or to continue the annual renewal process.

No vote was taken as this subject was for administrative clarification for board staff and surveyors.
