- 1. Request for approval of alternate training for categorical MT license**

Stephanie Poindexter, MAT, BSMLS (ASCP)^{CM}
Training Coordinator of the TDH Laboratory Services, Medical Technologist in Microbiology Specialty Training Program, Nashville, TN.
A plan of action was presented to combine the training of a graduate of the Southern Illinois University, Public Health Laboratory Sciences Master's program with an additional 6 months training at the TDH program. The board recognized this combined training as sufficient for the graduate to become eligible for licensure in Tennessee as a MT-Microbiology.

The motion was made by Mr. Johnson to accept this combined training for the individual in this particular case only, as a pathway to licensure as a MT-Microbiology. It was seconded by Dr. Calarco

- 2. Request for CLS courses to fulfill TN science course requirements.**

Teresa Nadder, Ph.D., MLS(ASCP)^{CM}
Chairman and Associate Professor of the Department of Clinical Laboratory Sciences, School of Allied Health Professions, Virginia Commonwealth University, proposed that the documentation that she presented proved that the graduates of the Clinical Laboratory Sciences program met the Tennessee chemistry and biology course requirements outlined in Rule 1200-06-01-.22(1)(g)

She provided the syllabi for the following VCU courses:
CLLS 410 Advanced Clinical Chemistry and Instrumentation
CLLS 311 Clinical Chemistry and Instrumentation I
CLLS 312 Clinical Chemistry and Instrumentation II
CLLS 307 Introduction to Pathogenic Microbiology
CLLS 308 Pathogenic Bacteriology
CLLS 408 Advanced Microbiology
CLLS 310 Clinical Immunology

She provided a comparison of the University of TN Knoxville Microbiology course BIOL 220 and the VCU training program microbiology courses CLLS 307, 308 and 408.

According to Dr. Nadder's interpretation of the Rule 1200-06-01-.22(1) (g), the VCU graduates met the requirements because they attended a NAACLS approved program that provided the course work equivalent to that required in a laboratory science education program. Since Rule 1200-06-01-.22(1)(a) (2) (i)(I) did not specifically state that 16 hours of chemistry, 16 hours of biology and 3 hours of math were required, the VCU program curriculum provided the necessary coursework for a valid pathway to licensure in Tennessee.

Dr. Nadder's presentation also led to a lengthy debate of the equivalency of the VCU training program and the Tennessee training programs.

After considerable deliberation, the committee members decided that they needed more time to re-evaluate the necessity of the biology, chemistry and math requirements in Rule 1200-06-01-.22(1)(g), if an applicant has graduated from a NAACLS accredited program.

Mr. Johnson made a motion to revisit the 16, 16, 3 requirements of Rule 1200-06-01-.22(1) (g), for licensure in Tennessee.

Ms. Kenwright seconded the motion.

Motion approved

The committee members concluded that as the rule was currently written, the graduates of VCU did not meet the requirements of the Tennessee rules 1200-06-01-.22(1) (g).

Mr. Johnson made the motion that until the rules were revisited, there would be no more discussion of the equivalency between programs, but to take licensure on a case by case basis.

Dr. Calarco seconded the motion.

**3. Request for
upgrade of MLT
license to MT
license**

Toni Said, MLS(ASCP)^{CM} from Bristol, VA a May, 2017 graduate of the VCU Clinical Laboratory Sciences program, petitioned the board to grant her an exemption from biology requirements of Rule 1200-06-01-.22 (1) (g). She was licensed as a MLT in Tennessee on November 16, 2017, because she lacked a course in general microbiology.

Her program director, Dr. Nadder, proposed that the board accept the three VCU Clinical Laboratory Science Program microbiology courses to satisfy the Tennessee microbiology requirements. Since the committee members ruled to revisit the course requirements of Rule 1200-06-01-.22 (1) (g) at a later date, Ms. Said transcript was evaluated on its own merits.

The committee members reviewed her transcript from East Tennessee State University and determined that an appropriate amount of microbiology could be found in two upper division biology courses to satisfy the requirement.

Dr. Calarco made the motion to grant the exemption by upgrading the Medical Technician license to a Medical Technologist license based on these biology courses and the microbiology from the training program courses. **It was seconded by Mr. Johnson.**
