Call to Order

After the roll call and with a quorum being present, Mr. Powell called the meeting to order at 9:05 A.M.

Contested Case Hearing

Case presented before the board on Shannon Gibson, RRT for failure to comply with a consent order from May 2018. In original consent order Ms. Gibson was placed on probation and ordered to attend TnPAP evaluation and follow any recommendations. Tracy Alcock made a motion for default on the case due failure of licensee response to multiple attempts of contact and the licensee not being present. Rob Wilson granted motion for default. Ms. Alcock presented evidence and witness statements supporting the state's case. TnPAP representative Mike Harkreader presented testimony to the board in regards to Ms. Gibson's failure to complete the TnPAP recommendations. After review of presented evidence and witness testimony, Ms. Alcock asked the board to revoke Ms. Gibson's license for failure to complete requirements of the of the consent order. Based on the information and testimony provided, Dr. Lovelady made a motion to accept the finding of facts as written. Motion seconded by Ray Davis. Motion carried. Dr. Gary Lovelady made a motion to accept the conclusions of law as written, seconded by Craig Rooks, Motion Carried, Dr. Gary Lovelady made a motion to accept the policy statement as written, seconded by Robert Farmer. Motion Carried. Kim Christmon made a motion to accept the proposed order as written, for the revocation of the license of Shannon Gibson, licensee is assessed two (2) Type B civil penalties in the amount of two-hundred (\$200) dollars each, totaling four-hundred dollars (\$400) to be paid within thirty (30) days of entry of the order, and prior to the reinstatement of her Tennessee respiratory license must complete a new TnPAP evaluation and comply with any and all recommendations, and licensee is responsible for all court costs associated with the hearing not to exceed the maximum of ten-thousand (\$10,000) within 30 days of the entry of the order seconded by Robert Farmer. Motion Carried.

Office of General Counsel Report

Tracy Alcock, Assistant General Counsel, presented the Office of General Counsel (OGC) report as follows:

Litigation

Ms. Alcock reports no current cases with OGC with the exception of the trial held.

Conflict of Interest

Ms. Alcock reminded the Board about the Conflict of Interest Policy. She reminded members of their obligation to recuse themselves from any matter in which they might have a personal or financial interest, or from participating in any matter before the board in which there might be an appearance of a conflict.

Investigative/Disciplinary Report

Lori Leonard, Disciplinary Coordinator, in the Office of Investigations, presented the investigative and monitored disciplined practitioners report as follows: For the monitored disciplined practitioners, there is one (1) practitioner under reprimand, six (6) practitioners under probation, and three (3) are suspended. Also, there were nine (9) revocations, and one (1) child support order to report.

For the year 2019, the Office received three (3) CRT complaints; all three (3) are for unprofessional conduct. So far in 2019 investigations has closed zero (0) complaints and currently have five (5) open complaints under review. For Respiratory Care Assistants, there are no new complaints and no complaints pending investigation at this time.

For RRTs, the number of renewals done online during this period constituted a usage rate of 88%, for CRTs the number of online renewals constituted a usage rate of 74%.

Correspondence

Constance Puckett- Requested waiver of CEU's during May 2019 board meeting. Per May meeting licensee was advised to obtain CEU's completed for previous employers before the board could make a decision. Ms. Puckett did not provide any continuing education as requested. Gail Braddock made a motion for her to attend the next board meeting and provided required paperwork or decision to grant or deny the waiver will be reached. Robert Farmer Seconded. Motion passed.

Melanie Kristy McClellan- Requested a waiver for obtaining continuing education due to no longer practicing. Kim Christmon recused herself. Dr. Lovelady made a motion to grant waiver. Mr. Rooks seconded. Motion passed.

New Legislation

Patrick Powell, representative of Legislative Affairs presented updates on everything that was passed in the last legislative session.

<u>Public Chapter 61</u>: Entities responsible for AED (Automatic External Defibrillator) programs are is immune from civil liability for personal injury that was not deemed willful or wanton misconduct. Rule passed March 28, 2019.

Chapter 144: Preventing youth Access to vapor and tobacco products

This prohibits the use of vapor products in the same manner as tobacco products with the exception of nursing home facilities. Took affect April 17, 2019.

Chapter 195: Expedited license

Military and military spouses can now be issued expedited licenses without showing proof of active employment. All application documents must be submitted. Took effect July 1, 2019.

Chapter 229: Bartering

This allows all health care professionals to accept goods and services as payment in direct exchange for health care services not covered by insurance.

Chapter 243: Accommodations for exams

This act requires that any required state issued exam with the exception of federal exams must provide appropriate accommodations per ADA rules.

Chapter 245: Nursing Title

This act prohibits any health professional that is not licensed by the Tennessee Board of Nursing from using the term nurse.

Chapter 303: Preventing youth access to including smoking hemp

Prohibit the sell or use of smoked hemp products to persons under the age of 18. Took effect July 1, 2019

Chapter 447: Law enforcement

This act permits Law enforcement agencies to subpoena records or documents pertaining to an ongoing case or investigations from Department of Health prior to formal charges being filed against the provider.

Rulemaking Hearings, Rule Amendments, and Policies

Tracy Alcock presented to the board the proposed changes for the delivery of respiratory care equipment rule per concerns presented by TSRC at the November 2018 board meeting. Ms. Alcock presented redline changes to the rules for the board to review. Changes to the rules will affect the delivery and home education, explanation and maintenance of respiratory equipment used by the patient at an in-home setting. After discussion between board members and TSRC representatives, an additional provision was requested that this rule will not affect medical professionals licensed under title 63 who are preforming actions under their scope of practice. Other small changes requested include the definition of place of residence, removing in-patient and out-patient setting, change humidifiers to add for nasal cannula and removal of duplicate line. Further discussion will be tabled until November 14, 2019 meeting. Ms. Alcock will present new draft with proposed changes during this meeting for further review and discussion.

Conferences

Kim Christmon presented her review of the AARC 2019 Summer Forum. Ms. Christmon discussed NBRC's new credentialing plan, allowing three (3) ways for respiratory therapists to demonstrate their continuing education, such as assessments, retaking national exam test, or obtaining new credential through testing. Based on results of assessments or exams NBRC will determine the number of continuing education that must be submitted. This will not affect those who obtained credentialing prior to 2002. NBRC plans to put this new plan into effect beginning in January 2020. Curtis Powell also attended the summer forum and gave his review on Ohio State University becoming the first school to offer and advanced practice respiratory care practitioner course. The future intent is for respiratory care practitioners to have specialty areas.

Discuss Old and New Business

Open board discussion on continuing to issue Certified Respiratory Therapists licenses and the schools offering the advanced practice option. Tracy Alcock requested tabling the discussion on the stopping issuing of new CRT license until next meeting.

Upcoming Conferences

Mary V. Webb reminded board members of upcoming conferences approved attendees. Gail Braddock requested to attend the FARB 2020 Forum in Colorado Spring, CO January 23-26, 2019. Ray Davis requested to attend the AARC Congress 2019 in New Orleans, LA November 9-12, 2019. Craig Rooks made a motion to attend, Robert Farmer seconded. Motion Passed.

Adjournment

There being no further business, Mr. Powell made to adjourn the meeting. The meeting was adjourned at 1:20 PM.
