Public Health Policy Coordinator

Provide leadership in the effort to improve County Health Council (CHC) capacity to implement upstream solutions to community health priorities, equipping them with tools to act on policy, systems, and environmental change through the County Health Assessment (CHA) and Community Health Improvement Process (CHIP).

This may include interagency collaboration, coordinating research, analysis, and community engagement, enhancing community understanding of engaging in public policy, integrating public health policy opportunities into the TDH Strategic Planning process, and development of resources and tools for CHCs to engage in policy discussions. This position will also support the CHC Community of Practice, a learning collaborative that promotes skills and relationship-building, and promotion of upstream, trauma-informed policy and resource solutions to build community resilience and address the social determinants of health.

Regional Strategic Planning Coordinator

Facilitate strategic planning by the state's regional and local health departments, enacting the department's strategic vision and goals while working directly with regional and local leadership. Develop structure, processes, and resources that foster local/regional strategic planning in alignment with state priorities, and offer support to regional and local leadership, with a focus on building processes that foster innovation.

Community Development Coordinator

Directly support the growing functions of Tennessee's local cross-sector health coalitions, County Health Councils (CHCs). The position will coordinate the various administrative elements of the grant funding process to support local-level assessment and implementation and will assist in preparing trainings to enable CHCs to write, obtain, and manage funds. The position will be located in Nashville, TN with statewide responsibilities. Additionally, the Community Development Coordinator will help to develop and maintain a funding resource guide for County Health Councils as they prepare to seek further funding to continue community-led work in service of minority and underserved populations.

This individual will build community capacity for fiscal agency, supporting the sustainability of CHC work, will support relationship development within the world of private philanthropy, and will improve community capacity and enhance TDH's ability to achieve multiple strategic objectives.

Business Intelligence Specialist
