EMS REPORT

At this February 5, 2019 Board for Licensing Health Care Facilities meeting, Robert Seesholtz, EMS Trauma System Manager, presented the following EMS report –

- August 11, 2018 Trauma Care Advisory Council (TCAC) meeting minutes were noted as available.
- University of Tennessee Medical Center had reverification Level I Trauma Center site visit conducted October 3-4, 2018 by the American College of Surgeons with verification as a Level I trauma center granted for one (1) year. Designation as a Level I trauma center is recommended for a three (3) year period.
- Sumner Regional Medical Center was revisited on January 4, 2019 for follow-up of the provisional Level III trauma center designation. Designation as a Level III trauma center is recommended for a three (3) year period.

Mr. Shulman made a motion to accept above report; seconded by Mr. Griffin. The motion was approved.

At the June 5, 2019 Board for Licensing Health Care Facilities meeting, Robert Seesholtz, EMS Trauma System Manager, presented the following EMS report –

- February 5, 2019 Trauma Care Advisory Council (TCAC) meeting minutes were presented.
- University of Tennessee Medical Center had the American College of Surgeons verification as a Level I trauma center extended until 2021.
- Regional One Medical Center's trauma site visit for 2018 is past due because of the lack of a lead reviewer. Mr. Seesholtz requested an extension of the facility's trauma designation. Hendersonville Medical Center's trauma site visit of May 2019 is past due because of the lack of a lead reviewer. Mr. Seesholtz requested an extension of the facility's trauma designation. Each of these facilities' reviews will take place in August of 2019.

Mr. Breeden made a motion to accept above report and to extend the trauma center designation of Regional One

Medical Center and Hendersonville Medical Center; seconded by Ms. Williford. The motion was approved.

NURSE AIDE REPORT

Wanda King, Nurse Aide Program Manager, presented the Nurse Aide Report. For the February 5, 2019 Board meeting, Ms. King presented this report to the Board which included the following –

- <u>Nurse Aide Certification</u> as of December 31, 2018 37,334 active nurse aides were certified in Tennessee. There were 9,393 new applicants certified during 2018. Forty-four (44) certifications were revoked and sixteen (16) were suspended for failure to pay child support.
- <u>Abuse Registry</u> as of December 31, 2018 2,439 persons were on the Registry of Persons Who Have Abused, Neglected, or Misappropriated the Personal Property of Vulnerable Individuals. There have been 161 placements during 2018 with breakdown as follows
 - County Courts: 53
 - TN Dept of Health: 9
 - o DIDD: 58
 - APS: 21
 - MHSAS: 20
- <u>Training Programs</u> there are 143 approved nursing home based training programs and 157 private training programs for a total of 300 approved programs.

There was not a report at the June 5, 2019 meeting.

INTERPRETIVE GUIDELINES

 SUBJECT: Supervision of "unskilled" services delivered in the patient's residence DATE: June 5, 2019 RULES: Home Health Agency 1200-08-26-.06(7)(c)

The Board for Licensing Health Care Facilities interprets the above regulation as the supervisory visit to the patient's residence may be conducted once every sixty (60) days. This interpretative guideline is intended to resolve a discrepancy between state regulations and 42 CFR § 484.36(d)(3), which requires a supervisory visit to the residence of a patient who is not receiving skilled nursing care, physical or occupational therapy or speech-language pathology services to occur at least once every sixty (60) days.

STATUTORY CHANGES OF INTEREST TO TENNESSEE HEALTH CARE FACILITIES

The 2019 Legislative Session has ended and the Board for Licensing Health Care Facilities' administrative staff has monitored several bills that are of interest to the licensed health care facilities in the state of Tennessee. Below is a brief summary of those bills. PUBLIC CHAPTER NO. 0012

This legislation clarifies that the definition of the practice of nursing does not prevent qualified registered nurses from making determinations that patients are experiencing emergency medical conditions in certain circumstances. This act took effect March 20, 2019.

PUBLIC CHAPTER NO. 0135

This legislation creates the elder abuse task force. This act took effect on April 9, 2019.

PUBLIC CHAPTER NO. 0183

This legislation permits advanced practice nurses and physician assistants who are prescribers at community mental health centers to arrange for chart review by and site visits with certain collaborating physicians by means of HIPAAcompliant electronic information systems. This act took effect on April 23, 2019

PUBLIC CHAPTER NO. 0239

This legislation revises the notice requirements with which a health care facility must comply under certain circumstances in order to preserve an assignment of health insurance benefits to an out-of-network facility based physician, or from collecting out-of-network charges from an insured. This act took effect on April 30, 2019.

PUBLIC CHAPTER NO. 0324

This legislation authorizes an existing licensed nursing home to relocate beds in certain circumstances. This act authorizes any existing licensed an operating nursing home to relocate 62 or fewer of its licensed beds to a new separate licensed nursing home if certain conditions are satisfies, including obtaining a certificate of need through the Health Services and Development Agency. There is only one nursing home that currently meets these conditions. This act took effect on July 1, 2019.

PUBLIC CHAPTER NO. 0341

This legislation enacts the "Healthcare Billing Clarity Act." This act prohibits hospitals from including in a billing statement to a patient any language that implies that a charge is for a specialty healthcare services, such as anesthesia, pathology, radiology, or emergency services, unless (1) the charge provides the patient with sufficient information to identify the healthcare provider or the specialty healthcare services rendered; and (2) the cost of supplies, equipment, or other services provided by the hospital are excluded from the amount charged for a specialty service or by a specialty provider; or (3) the billing statement informs the patient that the billed amounts for services do not include charges for healthcare providers not employed by the hospital. A hospital must include a notice or language on the billing statement if the charges are for supplies, equipment, or other services provided by the hospital. This act takes effect January 1, 2020.

PUBLIC CHAPTER NO. 0351

This legislation enacts the "Human Life Protection Act," which bans abortion in this state effective on the 30^{th} day after the U.S. Supreme Court overturns Roe v. Wade or an amendment to the U.S. Constitution to allow states to prohibit abortion; creates exception for situations where the abortion is necessary to prevent the death of a pregnant woman or prevent serious risk of substantial and irreversible impairment of major bodily function; prohibits prosecution of a woman upon who an abortion is performed or attempted. This act took effect May 10, 2019.

PUBLIC CHAPTER NO. 0407

This legislation enacts the "Tennessee Right to Shop Act." This act requires providers and facilities to provide a copy of an order for a comparable healthcare service within 2 days of request. This act takes effect on May 21, 2019 for all rules and January 1, 2020 for all others.

PUBLIC CHAPTER NO. 0447

This legislation creates an exception to provisions concerning the confidentiality of certain investigatory records of the division of health related boards in the department of health. This act took effect on May 22, 2019.
