Kshitiz Rastogi gave a presentation on the Child Care Labor Market. Deputy Campbell-Street noted that it would be interesting to see the impact of the DHS wage supplement program on the numbers presented during this time. Ryan Hughes noted that many centers don't qualify for the wages program due to various reasons, including some centers being licensed through the Department of Education rather than DHS.

Commissioner Carter noted that the group is currently unable to see the whole picture of the issues facing these centers because some do not register with Labor/Unemployment or with DHS. Vice-Chair Taylor noted that if the Taskforce wants to figure out a better picture of supply, they will also need to tackle demand as well. <u>Commissioner Carter asked for a subcommittee to be formed including at least one vice-chair on this issue.</u>
