The Tennessee Department of Human Services (TDHS) received funding for this ARPA Child Care Discretionary Supplemental Grant Subaward from the U.S. Department of Health and Human Services Administration for Children and Families (ACF) Office of Child Care under Federal Award No. 2101TNCDC6.

The ACF Office of Child Care determined that child care providers receiving ARPA Child Care Discretionary Supplemental Grant Subaward funds are not subrecipients and therefore characterized as beneficiaries of a federal program. Subawards should be considered contingent liabilities pending full satisfaction of all requirements as defined by the terms and conditions of the Notice of Award.
