Dear Ms. Clarke-Patterson,

The Department of Human Services (DHS) - Division of Audit Services staff conducted a limited desk review of the Summer Food Service Program (SFSP) at Deliverance Outreach Temple Church (Sponsor), Application Agreement number 00-022, during the period of June 2020 through August 2020. Our scope of the review was for reimbursement made to the Sponsor for Month 2020.

Based on our review of the Sponsor's records and information provided, the Sponsor had (10) feeding sites operating during the review period. The Clarksville- Montgomery Library (Clarksville Library)-37, Cumberland Manor-02, Deliverance Outreach Temple Church (Deliverance Outreach)-03, Eagle Crest Wallace (Eagle Crest)-06, Ebenezer AME Temple Church (Ebenezer AME)-16, Lincoln Homes09, Miller Town Apartments (Miller Town)-10, Power and Grace Academy-41, Renaissance at Peachers-47, and Summit Heights-14 sites were selected as the sample.

Due to the outbreak and the risk that COVID19 poses to the Sponsor and our staff, the review was limited to verification, based on review of the documents obtained from Sponsor, via e-mail, mail, or other electronic transmission of documents. We also, obtained confirmation from the feeding sites and Sponsor staff via telephone or e-mail relative to the operation and administration of the SFSP.

The purpose of this review was to determine if the Sponsor complied with USDA regulations set through the COVID-19 period, taking into consideration the waivers granted to the Sponsor's operation. Also, to determine if the Sponsor complied with the applicable *Title 7 of the Code of Federal Regulations* (CFR) applicable parts, provider agreements, and applicable Federal and State regulations.

Important COVID-19 note: Due the current outbreak and the risk that COVID19 poses to your organization personnel and our staff, all our staff are working from home with no or very limited access to the office. Background

SFSP Sponsors utilize meal count sheets to record the number of breakfast, lunch, supper, and supplement meals served. Meals served by participating Sponsors must meet the minimum guidelines set by the United States Department of Agriculture (USDA) and DHS to be eligible for reimbursement. The SFSP Sponsor reports the number of meals served through the DHS Tennessee Information Payment System (TIPS) to seek reimbursement.

We inspected meal counts sheets for our test period and reconciled the meals claimed to the meals reported as served for each meal service. We also assessed compliance with civil rights requirements. In addition, we observed we observed meal services at the sample sites throughout the review period.

Our review of the Sponsor's documentation for June 2020 and the combined months of July and August 2020 disclosed the following:

1. The Sponsor reported the number of meals claimed for reimbursement incorrectly

<u>Condition</u>

During our desk review with the Sponsor on August 11, 2020, we requested and reviewed meal count sheets to support the Claim for Reimbursement for sites operating during the review period.

We noted discrepancies as follows:

<u>Criteria</u>

Title 7 of the Code of Federal Regulations, Section 225.9 (d)(5) states, "... In submitting a claim for reimbursement, each sponsor shall certify that the claim is correct and that records are available to support this claim...."

Title 7 of the Code of Federal Regulations, Section 225.15(c)(1) states, "Sponsors shall maintain accurate records justifying all meals claimed and documenting that all Program funds were spent only on allowable Child Nutrition Program costs. Failure to maintain such records may be grounds for denial of reimbursement for meals served and/or administrative costs claimed during the period covered by the records in question. The sponsor's records shall be available at all times for inspection and audit by representatives of the Secretary, the Comptroller General of the United States, and the State agency for a period of three years following the date of submission of the final claim for reimbursement for the fiscal year."

The USDA <u>SFSP Administration Guide</u>, page 139, states, "All sponsors must use daily site records in order to document the number of Program meals they have served to children. The sponsor must provide all necessary record sheets to the sites. Site supervisors are then responsible for keeping the records each day. The site personnel must complete the records based on actual counts taken at each site for each meal service on each day of operation. Site personnel must be sure that they record all required counts."

Recommendation

The Sponsor should ensure that claims for reimbursement are completed correctly and based on accurate supporting documents.

2. The Sponsor claimed more meals than we observed during our monitoring visits

Condition

During our desk review with the Sponsor on August 11, 2020, we requested and reviewed meal count sheets to support the Claim for Reimbursement for sites operating during the review period. We also conducted on-site monitoring visits and reported the number of observed meals to the Sponsor. The Sponsor claimed more meals than we observed during our on-site monitoring visits at the sample sites as follows:

As a result, two (2) lunch meals and one (1) supplement were disallowed. (See Exhibits)

<u>Criteria</u>

Title 7 of the Code of Federal Regulations, Section 225.9 (d)(5) states, "... In submitting a claim for reimbursement, each sponsor shall certify that the claim is correct and that records are available to support this claim...."

Title 7 of the Code of Federal Regulations, Section 225.15 (c)(1) states, "Sponsors shall maintain accurate records justifying all meals claimed and documenting that all Program funds were spent only on allowable Child Nutrition Program costs. Failure to maintain such records may be grounds for denial of reimbursement for meals served and/or administrative costs claimed during the period covered by the records in question..."

Recommendation

The Sponsor should ensure that feeding site personnel perform and submit accurate meal count sheets and the Sponsor should ensure that the Claim for Reimbursement is completed correctly based on accurate and proper supporting documentation.

3. The Sponsor did not maintain racial and ethnic data as required

Condition

The Sponsor did not provide documentation supporting that the racial and ethnic data had been collected for **Ebenezer AME Church-16** as required.

<u>Criteria</u>

The USDA <u>SFSP Administration Guide</u>, page 122, states "... the Sponsor must collect ethnic/racial category data each year by ethnic/racial category for each site under the sponsor's jurisdiction."

Recommendation

The Sponsor should ensure that the racial/ethnic data for each site is collected at least one time during for each site operating in SFSP.

4. The Sponsor did not maintain delivery tickets

<u>Condition</u>

During our desk review with the Sponsor on August 11, 2020, we requested delivery tickets for sites served with meals delivered from a central kitchen during the review period. The Sponsor did not provide delivery tickets for any sites.

<u>Criteria</u>

The USDA <u>SFSP Administration Guide</u>, page 139, states "A designated member of the site staff must verify the adequacy and number of meals delivered by checking the meals when they are delivered to the site."

Recommendation

The Sponsor should ensure that delivery tickets accompany meals delivered for each site that receives meals from a central kitchen.

Technical Assistance Provided

The Sponsor requested technical assistance regarding production records and delivery tickets during our exit conference conducted on September 3, 2020. This request was forwarded to Program specialists for further assistance on September 3, 2020.

Disallowed Meals Cost

The disallowed meals cost associated with the findings above is below the DHS threshold for repayment

Corrective Action

The Sponsor must complete the following actions within 30 days from the date of this report:
