Update of Training Program by Tennessee 811

Mr. Ingram reported that 660 individuals, from 555 organizations, have been trained since the inception of the program. There have been 16 cancellations fees assessed for cancellation within the forty-eight hour window. Of the confirmed violations where training was ordered there has been no contact in 164 and contact was made in 48.

Update on the Public Awareness Campaign by Tennessee Gas Association

Kelley Zamboni reported that the grant received by TGA from the Board is being used for their public awareness campaign. TGA intends to expand its usual promotion efforts to include damage prevention for all underground utilities. They are working on multiple thirty second radio and television commercial pieces. The commercials are aired during unused or unsold airtime on the radio and television and are played throughout the state. They have a contract with the Tennessee Association of Broadcasters for the radio and television advertisements. TGA will be creating social media and print campaigns which will be distributed by TMEPA and TAUD. TGA will work on scripts and idea boards to present to the Board in November. Once the Board has reviewed the materials, TGA intends to go into full production.

Staffing Update

Marcia Jemmott is joining the Underground Damage Staff on August 8, 2022, to provide administrative and investigative support as well as assuming other functions performed by others. Monique Brazelton will transition off the Underground Damage Staff.

Discussion of Future Topics for the Next Executive Committee Meeting

There have been 155 complaints received so far year to date. There is a total of \$215,225 in civil fines assessed. The fund balance as of June 30 is \$114,350. The schedule of upcoming industry events was discussed. The next Executive Committee meeting is August 30. The legislature recommended a five year extension for the Board at the sunset hearing. The PHMSA checklist has been submitted.
