

**Automatic Teacher License Actions
Revocation and Permanent Revocation**

The Background:

Pursuant to T.C.A §§ 49-5-413, 49-5-417, and State Board of Education Rule 0520-02-03-.09(4)(a), the State Board of Education is required to automatically revoke or automatically permanently revoke the license of an educator for certain criminal offenses and classifications set forth in law. Pursuant to State Board Rule 0520-02-03-.09(4)(a)(1), educators whose conviction includes a Judicial Diversion plea taken in conjunction with T.C.A. § 40-35-313 or its equivalent in any other jurisdiction shall not be subject to automatic permanent revocation. All cases are reviewed and acted upon according to the rule that was in place when the conviction or qualifying event occurred.

State Board Rule 0520-02-03-.09(4)(b) requires that notice be sent to educators whose licenses are subject to automatic revocation or automatic permanent revocation at least thirty (30) days prior to the State Board meeting at which such revocation shall occur. All educators were sent proper notice in compliance with State Board Rule.

The Recommendation:

State law and State Board rules require the Board to take action, and State Board counsel recommends approval of the automatic licensure actions outlined in the attached document.

Automatic Teacher License Actions

- A. Patrick Albano - Automatic Permanent Revocation - Pled to a Class C felony charge of criminal attempt to commit sexual exploitation of a minor (T.C.A. 39-17-1003) and placed on the sex offender registry.

- B. David Boone - Automatic Permanent Revocation – Convicted of two (2) felony counts pursuant to M.C.A. § 97-5-23 (Mississippi) and sentenced to fifteen (15) years in prison, followed by ten (10) years post release supervision. Required to register as a sex offender.

- C. Adam Fleming – Automatic Permanent Revocation – Convicted of Solicitation of Sexual Exploitation of a Minor under T.C.A. § 39-13-529(b)(1) and placed on the sex offender registry.
