XML TRANSITION UPDATE - ARE YOU READY??

Please remember that as of November 1, 2022 we will no longer be able to accept flat files. Agencies not submitting data in the XML format will be subject to decertification. We DO NOT want that to happen. If you are not submitting weekly XML files, please contact Dale King as soon as possible!

AGENCY PERSONNEL OR-VENDOR CHANGES

All agencies have staffing changes at one time or another. If your agency Chief Law Enforcement Officer (CLEO), RAC, or Alt. RAC changes for any reason, please let us know!

There have been times when we contact an agency to speak with the RAC, only to find out he/she has resigned, been promoted, retired, etc., and is no longer the RAC. Sometimes when speaking with the RAC, we find out that the chief or sheriff is no longer with the agency. The agency may have an interim chief or sheriff or a new one has been appointed.

If the CLEO, RAC, or Alt. RAC changes, please submit the *TIBRS CLEO/RAC/Alternate RAC Change form*. Even if the CLEO is an interim, you still need to complete this form along with the *Memorandum of Understanding (MOU) Agreement*. Once a permanent CLEO is in place, you will need to submit <u>both of these forms</u> again.

If any of the information (i.e., Information Systems, RMS Admin, Network Systems or Legal Counsel) on the MOU changes at any time, it must be updated, again in its entirety.

Please contact your auditor for current forms (TIBRS CLEO/RAC/Alternate RAC Change, CrimeInsight Application, and Memorandum of Understanding, etc.). Happy trails!
