# TIBRS Changes for 2013

Changes for 2013 were recently distributed to agencies using vendors and Records Management System (RMS) vendors. The changes will be effective with the March 2013 submission due by April 10th. We will begin collecting three new offenses as part of national Human Trafficking legislation. The offenses are Human Trafficking—Commercial Sex Acts, Human Trafficking-Involuntary Servitude, and Prostitution-Patronizing. Specifics about the offenses, and edits were included in the documentation. The Hate Bias category will include the separate categories of Asian and Hawaiian/ Other Pacific Islander. Additionally, Tennessee will add specific data related to officer involved shooting incidents. We are also adding new edit checking to the system for robbery and credit card fraud among others. A new location code for movie theater will be added as well as information on repeat domestic violence victims and arrestees.

### Are the Reporting Agency Coordinator (RAC) and the RMS Administrator the same?

The Reporting Agency Coordinator (RAC) is the person responsible for the agency's TIBRS program and the first point of contact for the Crime Statistics Unit staff. This person is responsible for ensuring data quality and timely entry and submission of data. Notification of a change in this role should be submitted on the RAC/Alt RAC Change Notification Form. The RMS Administrator is the person responsible for the agency's access to the Tennessee Fusion System including CRMS and TnCOP. This person is responsible for reviewing usage by the agency and administration of the agency's user accounts. Notification of a change in this role is submitted on the MOU Contact Change Form. Both forms are available at www.tbi.tn.gov.

## **Training Issues**

#### **Reporting "Identity Theft" to TIBRS**

Due to the nature of the crime, in many cases the offender and victim are in different locations/ jurisdictions. In keeping with TIBRS jurisdictional reporting guidelines, if an agency knows that the crime occurred in their jurisdiction, then they are responsible for reporting the incident to TIBRS. In many cases, the victim will report the incident to law enforcement, but will not have any information as to where the actual theft took place. What they are actually reporting is the <u>use\_of</u> the card, as opposed to the <u>theft</u> of the card.

#### NEW TIBRS REPORTING GUIDELINES FOR FRAUDULENT USE OF A CREDIT/DEBIT CARD

If the card was used/transaction occurred over the internet or telephone, the reporting jurisdiction will be the victim's jurisdiction. If the card was used/transaction occurred in person, it should be reported by the jurisdiction where the purchase was made, regardless of where the victim lives. If it cannot be determined whether the purchase was made over the internet, telephone or in person, the incident should be reported by the jurisdiction where the victim resides.



#### EXAMPLE I:

Tim Griffin lives in Cookeville. While reading his credit card statement, he discovered a purchase that he had not made.

He called his credit card company. They told him to report the incident to law enforcement. Griffin's card had been used by an unknown person who had made a \$50 purchase (winter coat) from Kmart in Cookeville. Griffin called Cookeville P.D. Initially, they did not know how the credit card information was obtained, so there is nothing to report regarding that incident at this time. However, they must report the incident involving the use of the card, which occurred in their jurisdiction.

How is this reported? Again, at this point, the only reportable incident/offense is the <u>use</u> of the card. The theft of the card cannot be reported yet because there is no way to determine how the card was stolen. For TIBRS, this incident is reported as Credit Card/ATM Fraud. The property segment will include the purchase (Clothes/Furs) but will <u>not</u> include the card itself. If the offender signed anything while making the purchase, add a Counterfeiting/Forgery offense.

So what about the theft of the card/account information? It still isn't reportable until an investigation can determine how the card/account information was illegally obtained.

## **Training Issues (continued)**

#### EXAMPLE 2:

Sally Burns lives in Sevierville. While reading her credit card statement, she discovered a purchase that she had not made.

Sally called her credit card company. They told her to report the incident to law enforcement. Her card had been used by an unknown person who made a \$125 purchase (purse) over the internet. Burns called Sevierville P.D. Initially, they did not know how the credit card information was obtained, so once again, there is nothing to report regarding that incident at this time. However, they must report the incident involving the use of the card, because the victim resides in their jurisdiction.

For TIBRS, this incident is also reported as Credit Card/ATM Fraud. The property segment will include the purchase (Purses/Handbags/Wallets) but will <u>not</u> include the card itself.

#### <u>REPORTING AN INCIDENT CONTAINING GROUP A AND OFFENSE(S),</u> <u>SAME OFFENDER</u>

When an incident occurs involving a Group A offense <u>and</u> a Group B offense committed by the same offender, only the Group A offense is reported.


#### EXAMPLE:

A subject is arrested and charged with Simple Assault *and* Public Intoxication. In TIBRS, Simple Assault is a Group A offense, while Public Intoxication is a Group B offense. Per FBI/NIBRS rules, only the Group A Simple Assault offense is reported to us. The incident will be marked as alcohol related and the narrative will contain the information regarding the P.I. charge.


#### THERE IS ONE (AND ONLY ONE) EXCEPTION TO THIS RULE

When the same offender is charged with DUI <u>and</u> a Drug/Narcotic Violation (occurring in the same incident), you have the <u>option</u> of reporting BOTH offenses. However, if the incidents are submitted together, the system will only count the Group A offense. When choosing to report both offenses, you <u>MUST</u> create/assign a <u>unique incident number</u> when submitting the second incident of DUI.

Again, this exception <u>ONLY</u> applies to DUI and Drug/Narcotic Violations that are perpetrated by the same offender in the same incident. Remember, you MUST report the Drug/ Narcotic Violation, but reporting the DUI is optional. Although we definitely encourage agencies to report the DUI as a separate incident, it is not mandatory.







### **Reporting Smurfing Offenses**

After discussion of the drug-related reporting requirements, the following recommendation is made when reporting "smurfing" offenses (buying over the allotted amount of pseudo/ephedrine): This particular over-the-counter drug requires additional interaction with the pharmacist and we suggest that the "drug-related" information should be reported as "Other Prescription Drugs" with a drug origin code of "diverted".



## **Cargo Theft/School Code Errors**

We continue to receive questions concerning errors on cargo theft and the old School code. You only need to correct these fields on old incidents if the incident is opened for editing for other reasons such as adding recovered property or an arrest. At that point, you must edit the location code if the offense has the old school/college code to avoid an error. Additionally, if the incident has an offense requiring an entry for cargo theft, that entry must be included with the re-submission of the old incident.
