The information contained in the report is based on crime statistics information submitted by law enforcement agencies, colleges and universities in Tennessee to TBI's Tennessee Incident Based Reporting System (TIBRS) program. TIBRS is the state version of the FBI's National Incident Based Reporting System (NIBRS) program. I am very proud of the efforts of all participating law enforcement agencies in the state to provide the data necessary to produce this report. LEOKA Overview

The total number of LEOKA incidents decreased by 4.3% since 2019, but have overall increased by 3.5% since 2017. The offense of Simple Assault continues to be the highest reported offense reaching a total of 1,293 in 2020, decreasing by 7.7% since 2019. Zero murders were reported and one Stalking incident was reported in 2020.




All incidents can be Cleared by Arrest or by Exceptional Clearance which include: Death of Offender, Prosecution Declined, In Custody of Other Jurisdiction, Victim Refused to Cooperate and Juvenile/ No Custody. Out of the 2,332 LEOKA incidents in 2020, 81.0% were Cleared by Arrest, 1.8% were cleared by Exceptional Clearance and 17.3% were Not Cleared.

Victim Analysis

In 2020, reports show that Male officers made up 88.4% of reported victims while Female officers accounted for 10.8% of the victims. There were victims with an Unknown gender that made up the other 0.8% of the victims. Officers between the age of 25-34 made up the highest amount with 52.1% of the reported victims while the second highest age group was 35-44 accounting for 19.3% of reported victims. White officers made up 89.5% of reported victims while Black or African American officers were the second most reported with 9.1% of reported victims.



Police officers who had a Vehicle Assignment of One-Officer Vehicle (Assisted) accounted for 40.8% of reported incidents, whereas One-Officer Vehicle (Alone) Vehicle Assignment totaled 33.4% of reported victims.



LEOKA Injuries and Weapons Used

Per TIBRS, up to five injury types can be reported per victim. Injury Type is a required data element when reporting Aggravated Assault and Simple Assault. There was a total of 2,206 reported Injury Types in 2020. The most reported Injury Type was None with 73.0% while 24.4% of the incidents reported were with an Apparent Minor Injury.



Per TIBRS, up to three weapons can be reported per incident. Personal Weapons were the most reported Weapon Type accounting for 53.3% of all weapon types reported. Motor Vehicle/ Vessel was the second most reported accounting for 17.5% of weapon types reported.



Timing of LEOKA Incidents

When looking at the LEOKA incidents and when they occurred during the week, Saturday was the most reported day with 16.1% of the incidents while Sunday was the second most reported totaling 15.6% in 2020. The lowest reported days of the week for LEOKA incidents were Monday and Thursday, both accounting for 12.7% of reported incidents.



The most frequently reported time of day for LEOKA incidents was the time period between 9:00pm- 11:59pm accounting for 21.3% while the second most frequently reported time was 6:00pm- 8:59pm reporting 18.2% of the LEOKA incidents in 2020. The lowest reported time of day for LEOKA incidents was the time period of 6:00am- 8:59am (4.7%).

Per TIBRS, incidents may have a secondary location to provide a more descriptive location. There was a total of 2,458 location codes reported in 2020. The most frequently reported location was Highway/Road/Alley at 32.2% with the second most reported location was Residence/Home at 28.0%.

Aggravated Assault was the offense most associated with LEOKA incidents occurring at the location of Highway/Road/Alley making up over 56.1% of reported incidents at that location.


Simple Assault was the offense type that was most reported when the location was Residence/Home accounting for 65.7% of LEOKA incidents at that location.

Offender Analysis

Most offenders involved in LEOKA incidents were Male accounting for 72.3% while Female offenders made up 25.5% and an Unknown offender gender made up the remaining 2.2% of offenders reported. The most frequently reported age group for offenders was 25-34 with 33.7% with the second most reported age was 35-44 with 21.8%.



The highest reported Race for an offender was White with 63.9% and Black or African American was the second most frequently reported with 32.9%. Offenders with an Unknown Race made up 2.8% while American Indian (0.3%) and Asian (0.3%) accounted for the remaining offenders.



LEOKA Victims and Activity Type

Every time an officer is assaulted in the line of duty, the type of activity in which the officer was engaged at the time of the assault is reported. A total of 27.1% of LEOKA victims in 2020 reported an activity type of Responding to Disturbance Call. The second most frequently reported activity type was Attempting Other Arrests with 17.6%. The least reported activity type reported was Robberies in Progress or Pursuing Robbery Suspects at 1.8%.

The table below shows the specific offense that was identified with the Activity Types. Simple Assault was the most reported offense when the activity type was Responding to Disturbance Call accounting for 63.7% of all offenses with that activity type. Aggravated Assault was reported the most when the activity type was Traffic Pursuits and Stops.
